Criminal Law - Theft of Rental Property

- FOR the purpose of prohibiting a person from hiring or leasing personal property or 3 equipment from another person who is in lawful possession of the personal 4 property or equipment with intent to defraud that person of the rental due 5 6 under the rental agreement; prohibiting a person from abandoning or willfully refusing to redeliver personal property as required under a rental agreement 7 8 without the consent of the lessor or the lessor's agent with intent to defraud the 9 lessor or the lessor's agent; establishing penalties for a violation of this Act; making technical corrections; and generally relating to theft of rental property. 10
