#### 1 AN ACT concerning

# Immunity from Liability – Medical Emergency – Use of Automated External Defibrillator

- 4 FOR the purpose of providing immunity from civil liability under certain circumstances, notwithstanding certain other provisions of law, to an individual 5 6 or facility that acquires an automated external defibrillator (AED) or that owns, 7 manages, or is responsible for the premises where an AED is located, to a 8 certain individual who retrieves an AED, or to a certain individual who uses, 9 attempts to use, or fails to use an AED in response to a sudden cardiac arrest 10 emergency at a facility; altering, under the Automated External Defibrillation 11 Program of the Maryland Institute for Emergency Medical Services Systems, the circumstances under which an individual is immune from civil liability for 12 providing automated external defibrillation; providing that immunity from 13 14 liability is not available to certain persons for certain conduct that is grossly negligent, willful or wanton misconduct, or intentionally tortious conduct; and 1516 generally relating to immunity from liability for use of an automated external 17defibrillator.
