The authority hereby conferred 16 17is subject to the limitation that the county shall issue no amount of bonds pursuant to 18 this section if, by the issuance thereof, the total unpaid bonded indebtedness under 19 this section, less the amount of any sinking funds or reserves for payment of bonds 20previously issued, shall exceed [fifteen (15)] SIX (6) per centum of the total assessed 21valuation of all property in Frederick County, subject to unlimited county taxation during the fiscal year of the county most recently concluded. 22

29 SECTION 2. AND BE IT FURTHER ENACTED, That the publishers of the 30 Annotated Code of Maryland, subject to the approval of the Department of Legislative 31 Services, shall make any changes in the text of the Annotated Code necessary to 32 effectuate any termination provision that was enacted by the General Assembly and 33 has taken effect or will take effect prior to October 1, 2008. Any enactment of the 2008 34 Session of the General Assembly that negates or extends the effect of a previously 35 enacted termination provision shall prevail over the provisions of this section.

1 SECTION 3. AND BE IT FURTHER ENACTED, That the Drafter's Notes 2 contained in this Act are not law and may not be considered to have been enacted as 3 part of this Act.

4 SECTION 4. AND BE IT FURTHER ENACTED, That the provisions of this 5 Act are intended solely to correct technical errors in the law and there is no intent to 6 revive or otherwise affect law that is the subject of other acts, whether those acts were 7 signed by the Governor prior to or after the signing of this Act.

8 SECTION 5. AND BE IT FURTHER ENACTED, That any reference in the 9 Annotated Code of Maryland rendered incorrect or obsolete by an Act of the General 10 Assembly of 2008 shall be corrected by the publishers of the Annotated Code, in 11 consultation with and subject to the approval of the Department of Legislative 12 Services, with no further action required by the General Assembly. The publishers 13 shall adequately describe any such correction in an editor's note following the section 14 affected.

15SECTION 6. AND BE IT FURTHER ENACTED, That the publishers of the Annotated Code of Maryland, in consultation with and subject to the approval of the 16 17Department of Legislative Services, at the time of publication of a new supplement, 18 new volume, or replacement volume of the Annotated Code, shall make 19 nonsubstantive corrections to codification, style, capitalization, punctuation, grammar, 20 spelling, and any reference rendered incorrect or obsolete by an Act of the General 21Assembly, with no further action required by the General Assembly. The publishers 22shall adequately describe any such correction in an editor's note following the section 23affected.

SECTION 7. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three-fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
