Prince George's County - Alcoholic Beverages - Convention Center License

3 FOR the purpose of establishing a Class B-CC (convention center) beer, wine and 4 liquor license in Prince George's County; specifying that a license may be issued 5 only to a certain establishment that is equipped with certain rooms and 6 facilities; providing for an annual license fee; requiring that the total average 7 daily receipts from certain sources exceed the average daily receipts from the 8 sale of alcoholic beverages; specifying certain hours of sale; authorizing the sale 9 of alcoholic beverages from locked, prestocked private bars under certain circumstances; authorizing the sale of alcoholic beverages and dancing and live 10 11 entertainment throughout the licensed establishment; specifying that this Act does not preclude a license holder from having an interest in certain other 12 licenses; providing for certain exceptions to certain licensing restrictions; 13 14 making this Act an emergency measure; and generally relating to the Class B-CC (convention center) alcoholic beverages license in Prince George's County. 15

SECTION 2. AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
