### A BILL ENTITLED

1 AN ACT concerning

#### 2 Gas Companies and Electric Companies – Annual Reports

- FOR the purpose of requiring each gas company and each electric company to file a
  separate annual report for each of its nonregulated affiliated or subsidiary
  companies that operates in the State; and generally relating to annual reports
  submitted by gas companies and electric companies to the Public Service
  Commission.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

- 15 Article Public Utility Companies
- 16 6–205.
- 17 (a) (1) This subsection does not apply to railroads.

18 (2) Except as provided in subsection (b) of this section, each public 19 service company shall file with the Commission an annual report containing 20 information on its corporate structure, affiliations of its officers and directors, and debt 21 holdings.

(3) EACH GAS COMPANY AND EACH ELECTRIC COMPANY SHALL
 FILE A SEPARATE ANNUAL REPORT IN ACCORDANCE WITH THIS SUBTITLE FOR
 EACH OF ITS NONREGULATED AFFILIATED OR SUBSIDIARY COMPANIES THAT
 OPERATES IN THE STATE.

#### **SENATE BILL 721**

1 (4) (i) Notwithstanding any specific reporting requirements in this 2 subtitle, the Commission may prescribe the contents of [the] EACH annual report to be 3 filed by a public service company whose gross annual revenues for the most recent 4 calendar year for which data are available are less than 0.003% of the total gross 5 annual revenues of all public service companies in the State during the same calendar 6 year.

7 (ii) A small rural electric cooperative described in § 7–502(a) of 8 this article may satisfy the reporting requirement by submitting to the Commission a 9 copy of a report including the required information that the small rural electric 10 cooperative submits to the rural utilities service.

11 (b) Unless otherwise directed by the Commission, a public service company is 12 not required to comply with subsection (a) of this section if the public service company 13 is:

14 (1) a common carrier; or

15 (2) a telephone company whose rates are not regulated by the16 Commission under Title 4 of this article.

17 (c) The president, treasurer, or general manager of a public service company18 shall verify the company's annual report under oath.

19 (d) The Commission may:

20 (1) require a public service company to submit reports and information 21 that the Commission reasonably desires;

22 (2) prescribe the form, contents, and deadlines for the reports and 23 information; and

24 (3) require amendments or corrections to the reports within a set 25 period.

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 27 October 1, 2008.
