# 2 Transportation – Maryland Emergency Medical System Operations Fund – 3 Transport by Privately Owned Helicopter

FOR the purpose of requiring that an operator of a privately owned helicopter be
reimbursed from the Maryland Emergency Medical System Operations Fund for
costs incurred in transporting individuals for emergency medical treatment;
adding reimbursement of operators of privately owned helicopters for costs of
emergency medical transport as an authorized use of money in the Fund; and
generally relating to the Maryland Emergency Medical System Operations
Fund.
