A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 – Prince George’s County**
3 **– New Revival Center of Renewal**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to change the grantee from the County Executive and County Council of Prince
6 George’s County to the Board of Directors of New Revival Center of Renewal,
7 Inc. and extending the deadline by which the grantee may present evidence to
8 the Board of Public Works that a matching fund will be provided.

9 BY repealing and reenacting, with amendments,
10 Chapter 46 of the Acts of the General Assembly of 2006
11 Section 1(3) Item ZA01 (CA) and ZA02 (BU)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
13 MARYLAND, That the Laws of Maryland read as follows:

22 **REVIVAL CENTER OF RENEWAL, INC.** for the acquisition of
23 land for the New Revival Center for Renewal, located in
24 Capitol Heights. **NOTWITHSTANDING SECTION 1(5) OF**
25 **THIS ACT, THE GRANTEE HAS UNTIL JUNE 1, 2009, TO**
