8	facility in order to achieve enhanced nutrient removal performance levels.
9	(4) (i) All wastewater facilities serving Maryland users that have
10	contributed to the Bay Restoration Fund are eligible for grants under this section,
11	including the Blue Plains Wastewater Treatment Plant in the District of Columbia.
12	(ii) Grants issued under paragraph (2)(i) of this subsection for
13	upgrades to the Blue Plains Wastewater Treatment Plant may be awarded only if each
14	party to the Blue Plains Intermunicipal Agreement of 1985 contributes a proportional
15	share of the upgrade costs in accordance with the Blue Plains Intermunicipal
16	Agreement of 1985, as revised and updated.
17	(5) Priority for funding an upgrade of a wastewater facility shall be
18	given to enhanced nutrient removal upgrades at wastewater facilities with a design
19	capacity of 500,000 gallons or more per day.
20	(6) (i) The eligibility and priority ranking of a project shall be
21	determined by the Department based on criteria established in regulations adopted by
22	the Department, in accordance with subsection (k) of this section.
23	(ii) The criteria adopted by the Department shall include, as
24	appropriate, consideration of:
25	1. The cost-effectiveness in providing water quality
26	benefit;
27	2. The water quality benefit to a body of water identified
28	by the Department as impaired under Section 303(d) of the Clean Water Act;
29	3. The readiness of a wastewater facility to proceed to
30	construction; and
31	4. The nitrogen and phosphorus loads discharged by a
32	wastewater facility.
33	(7) A wastewater facility that has not been offered or has not received
34	funds from the Department under this section or from any other fund in the

Department may not be required to upgrade to enhanced nutrient removal levels, except as otherwise required under federal or State law.
