1 AN ACT concerning

2 **Health Insurance – Public–Private Health Care Programs**

3 FOR the purpose of requiring a person to be certified by the Maryland Insurance
4 Commissioner before operating a public–private health care program in the
5 State; establishing certain requirements an applicant for certification must
6 meet; requiring the Commissioner to certify an applicant to operate a
7 public–private health care program under certain circumstances; providing for
8 the expiration and renewal of a certification; requiring a certified nonprofit
9 corporation to comply with and be subject to certain provisions of law; requiring
10 a public–private health care program to disapprove an application under certain
11 circumstances; authorizing the Commissioner to deny a certification to an
12 applicant or refuse to renew, suspend, or revoke a certification under certain
13 circumstances; requiring that all forms, agreements, advertising, or other
14 documents provided to participants in a public–private health care program be
15 truthful and not misleading and be made available to the Commissioner on

28 (B) AN APPLICANT FOR CERTIFICATION SHALL:

1 (1) BE A NONPROFIT CORPORATION THAT, IN ACCORDANCE WITH
2 ITS CHARTER, IS ORGANIZED FOR THE PURPOSE OF ESTABLISHING AND
3 OPERATING A PUBLIC-PRIVATE HEALTH CARE PROGRAM; AND

4 (2) FILE WITH THE COMMISSIONER:

14 AMENDMENTS TO THE BYLAWS;

15 3. A LIST OF THE NAME, ADDRESS, AND
16 BIOGRAPHICAL INFORMATION FOR EACH MEMBER OF THE BOARD OF
17 DIRECTORS OF THE APPLICANT; AND

18 4. A LIST OF THE BEGINNING AND ENDING TERMS OF
19 OFFICE OF EACH MEMBER OF THE BOARD OF DIRECTORS OF THE APPLICANT;

20 (III) THE WRITTEN AGREEMENT WITH EACH COUNTY IN
21 WHICH THE APPLICANT PROPOSES TO OPERATE A PUBLIC-PRIVATE HEALTH
22 CARE PROGRAM THAT SPECIFIES THE OBLIGATIONS OF EACH PARTY TO THE
23 AGREEMENT;

24 (IV) A DESCRIPTION OF THE PUBLIC-PRIVATE HEALTH CARE
25 PROGRAM THE APPLICANT PROPOSES TO OPERATE, INCLUDING:

26 1. THE CRITERIA USED TO DETERMINE WHO IS A
27 QUALIFYING INDIVIDUAL;

28 2. THE ARRANGEMENTS FOR THE DELIVERY OF
29 HEALTH CARE SERVICES;

13 (A) THE COMMISSIONER SHALL CERTIFY AN APPLICANT TO OPERATE A
14 PUBLIC-PRIVATE HEALTH CARE PROGRAM IF THE COMMISSIONER IS SATISFIED
15 THAT THE APPLICANT:

16 (1) HAS BEEN ORGANIZED IN GOOD FAITH FOR THE PURPOSE OF
17 ESTABLISHING AND OPERATING A PUBLIC-PRIVATE HEALTH CARE PROGRAM;

18 (2) IS COMMITTED TO A NONPROFIT CORPORATE STRUCTURE;
19 AND

20 (3) HAS SUFFICIENT FUNDS TO MEET ITS OBLIGATIONS UNDER
21 THE PUBLIC-PRIVATE HEALTH CARE PROGRAM.

22 (B) A CERTIFICATION EXPIRES ON THE THIRD JUNE 30 FOLLOWING
23 THE DATE ON WHICH THE CERTIFICATION WAS LAST ISSUED UNLESS IT IS
24 RENEWED AS PROVIDED IN THIS SECTION.

25 (C) BEFORE A CERTIFICATION EXPIRES, A CERTIFIED NONPROFIT
26 CORPORATION MAY RENEW IT FOR AN ADDITIONAL 3-YEAR TERM IF THE
27 CERTIFIED NONPROFIT CORPORATION:

28 (1) OTHERWISE IS ENTITLED TO CERTIFICATION; AND

29 (2) FILES WITH THE COMMISSIONER A RENEWAL APPLICATION
30 ON THE FORM THAT THE COMMISSIONER REQUIRES.

1 (D) AN APPLICATION FOR RENEWAL OF A CERTIFICATION SHALL BE
2 CONSIDERED MADE IN A TIMELY MANNER IF IT IS POSTMARKED ON OR BEFORE
3 JUNE 30 OF THE YEAR OF RENEWAL.

22 (1) MAKES A MATERIAL MISSTATEMENT OR MISREPRESENTATION
23 IN AN APPLICATION FOR CERTIFICATION;

24 (2) FRAUDULENTLY OR DECEPTIVELY OBTAINS OR ATTEMPTS TO
25 OBTAIN A CERTIFICATION FOR THE APPLICANT OR CERTIFIED NONPROFIT
26 CORPORATION OR FOR ANOTHER;

27 (3) HAS BEEN CONVICTED OF A FELONY OR OF A MISDEMEANOR
28 INVOLVING MORAL TURPITUDE;

29 (4) IN CONNECTION WITH THE PUBLIC-PRIVATE HEALTH CARE
30 PROGRAM, COMMITS FRAUD OR ENGAGES IN ILLEGAL OR DISHONEST
31 ACTIVITIES;

1 (5) HAS VIOLATED ANY PROVISION OF THIS SUBTITLE OR A
2 REGULATION ADOPTED UNDER THIS SUBTITLE;

3 (6) PROVIDES A FALSE, FALSELY DISPARAGING, OR MISLEADING
4 ORAL OR WRITTEN STATEMENT, VISUAL DESCRIPTION, OR OTHER
5 REPRESENTATION OF ANY KIND THAT HAS THE CAPACITY, TENDENCY, OR
6 EFFECT OF BEING DECEPTIVE OR MISLEADING; OR

7 (7) MAKES A REPRESENTATION THAT A PUBLIC-PRIVATE HEALTH
8 CARE PROGRAM HAS A SPONSORSHIP, APPROVAL, CHARACTERISTIC, USE, OR
9 BENEFIT THAT IT DOES NOT HAVE.

10 (B) SUBJECT TO THE HEARING PROVISIONS OF TITLE 2, SUBTITLE 2 OF
11 THIS ARTICLE, THE COMMISSIONER MAY REFUSE TO RENEW, SUSPEND, OR
12 REVOKE THE CERTIFICATION OF A CERTIFIED NONPROFIT CORPORATION IF
13 THE CERTIFIED NONPROFIT CORPORATION OR THE PUBLIC-PRIVATE HEALTH

2 31, 2010, the Maryland Insurance Administration shall report, in accordance with §
3 2–1246 of the State Government Article, to the Senate Finance Committee and the
4 House Health and Government Operations Committee on the Administration’s
5 recommendations for the continuation of public–private health care programs in the
6 State.

7 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
8 June 1, 2008. It shall remain effective for a period of 5 years and, at the end of May 31,
9 2013, with no further action required by the General Assembly, this Act shall be
10 abrogated and of no further force and effect.
