## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2007 – Worcester County –**  
3 **Delmarva Discovery Center on the Pocomoke River**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2007  
5 to expand the authorized uses of a certain grant to the Board of Directors of the  
6 Pocomoke Marketing Partnership, Inc.

7 BY repealing and reenacting, with amendments,  
8 Chapter 488 of the Acts of the General Assembly of 2007  
9 Section 1(3) Item ZA01(BV) and ZA02(CE)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That the Laws of Maryland read as follows:
