Exhibitors – Licensure – National Convention Exemption

- FOR the purpose of specifying that the exemption from the trader's license requirement imposed on exhibitors applies to exhibitors that provide the promoter with an affidavit stating that the exhibitor has not participated in more than three shows, not including participation in a certain national show, in addition to the current annual income requirements; and generally relating to the licensure of exhibitors.

1 "Chain store license" means a license issued by the clerk to operate 2 or (c) $\mathbf{2}$ more stores under the same general management or ownership. 3 (d) "Exhibitor" means a person who rents space from a promoter to display and sell goods at a show. 4 "Licensed trader" means a trader who is licensed by the clerk under this $\mathbf{5}$ (e) subtitle. 6 "Promoter" means a person who rents space at a show to an exhibitor. $\mathbf{7}$ (**f**) 8 (**g**) "Show" includes an antique show, coin show, flea market, gun show, 9 stamp show, and show of a temporary nature. 10 17 - 1804.(a) 11 Except as otherwise provided in this subtitle, a person must have a trader's license whenever the person: 1213 (1)does business as a trader in the State; or 14 (2)does business as an exhibitor in the State. 15(**d**) (2)An exhibitor need not get a trader's license for a show if the 16 exhibitor gives to the promoter an exhibitor's affidavit stating that the exhibitor: receives less than 10% of the exhibitor's annual income from 17 (i) selling the kind of goods that the exhibitor will display and sell at the show; and 18 19 (ii) has not participated in more than 3 shows, NOT INCLUDING 20PARTICIPATION IN ONE SHOW SPONSORED BY A NATIONAL ORGANIZATION THAT 21IS EXEMPT FROM TAXATION UNDER § 501(C)(3) OF THE INTERNAL REVENUE 22**CODE.** during the previous 365 days. 23SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 24October 1, 2008.
