- 3 FOR the purpose of prohibiting a lessor from passing on to the lessee the portion of the 4 motor vehicle excise tax paid by the lessor on the residual value of a leased vehicle; providing that a lessor is entitled to a refund of the portion of the motor vehicle excise tax paid by the lessor on the residual value of a leased vehicle; requiring a lessor to apply to the Motor Vehicle Administration on a certain form in order to obtain a refund; defining certain terms; and generally relating to the motor vehicle excise tax and the residual value of leased vehicles.

- 8 (B) AS PART OF A LEASE AGREEMENT, THE LESSOR MAY NOT PASS ON 9 TO THE LESSEE THE PORTION OF THE EXCISE TAX PAID BY THE LESSOR ON THE 10 RESIDUAL VALUE OF THE LEASED VEHICLE.
- 11 (C) (1) AFTER ENTERING INTO A LEASE AGREEMENT, THE LESSOR IS 12 ENTITLED TO A REFUND OF THE PORTION OF THE EXCISE TAX PAID BY THE 13 LESSOR ON THE RESIDUAL VALUE OF THE LEASED VEHICLE.
- 14 (2) TO OBTAIN A REFUND UNDER THIS SUBSECTION, THE LESSOR 15 SHALL APPLY TO THE ADMINISTRATION ON A FORM THE ADMINISTRATION 16 REQUIRES.
- 17 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect 18 October 1, 2008.
