A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2006 - Montgomery County -**
3 **Our House Youth Home**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2006
5 to extend the deadline by which the Board of Directors of Our House Youth
6 Home, Inc. may present evidence to the Board of Public Works that a matching
7 fund will be provided.

8 BY repealing and reenacting, with amendments,
9 Chapter 46 of the Acts of the General Assembly of 2006
10 Section 1(3) Item ZA01(CP) and ZA02(AZ)

11 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
12 MARYLAND, That the Laws of Maryland read as follows:

17 (CP) Our House Youth Home. Provide a grant equal to the lesser of
18 (i) \$175,000 or (ii) the amount of the matching fund provided,
19 to the Board of Directors of Our House Youth Home, Inc. for
20 the construction and capital equipping of a new dormitory at
21 Our House Youth Home, located in Olney, subject to a
22 requirement that the grantee grant and convey a historic
23 easement to the Maryland Historical Trust.
24 **NOTWITHSTANDING SECTION 1(5) OF THIS ACT, THE**
25 **GRANTEE HAS UNTIL JUNE 1, 2009, TO PRESENT**
