## A BILL ENTITLED

1 AN ACT concerning

3 FOR the purpose of requiring that public school students in kindergarten through a 4 certain grade be provided certain minimum levels of a program of physical 5 activity each week; requiring that the program of physical activity for a certain 6 category of student be consistent with a certain plan for the student; requiring 7 public elementary schools to designate a certain group to plan and coordinate 8 certain activities; requiring students in public high schools to complete a certain 9 amount of physical education in order to graduate; requiring the State Board of 10 Education to adopt certain regulations; providing for certain extensions; and generally relating to student health and fitness. 11

22 Preamble

WHEREAS, Obesity leads to at least 300,000 deaths among adults in the United States each year due in part to physical inactivity and a poor diet; and

WHEREAS, Inadequate participation in physical activity is a significant contributor to the "epidemic of obesity" that has plagued the nation's young people during the past 2 decades; and

WHEREAS, Physical activity offers young people many health benefits, including improving aerobic endurance and muscular strength, helping to control weight, building lean muscle and reducing fat, and helping to build greater bone mass, all of which thwart the development of osteoporosis in adulthood and prevent or reduce high blood pressure; and

WHEREAS, A growing body of evidence suggests that providing students with more physical education and physical activity opportunities helps reduce the costs schools incur by reducing absenteeism, improving student health, and reducing staff time spent addressing academic performance; and

WHEREAS, A growing body of evidence also suggests that improvement in test scores and overall academic achievement can be linked to increased time in physical education; and

WHEREAS, The National PTA considers "Early Physical Education" a "Parent Priority" and urges its members to promote physical education in the schools; now, therefore,

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 20 MARYLAND, That the Laws of Maryland read as follows:

## 21 Article – Education

- 23 (a) The promotion of students in a public school and graduation from a public 24 high school shall be in accordance with:
  - (1) Policies established by the county board; and
- 26 (2) The rules and regulations of the State Board.

(a) [Each] SUBJECT TO SUBSECTIONS (B) AND (C) OF THIS SECTION, EACH public school shall have a program of physical education that is given in a planned and sequential manner to all students, kindergarten through grade 12, to develop their good health and physical fitness and improve their motor coordination and physical skills.

- 1 (B) (1) ALL STUDENTS IN KINDERGARTEN THROUGH GRADE 8 SHALL 2 BE PROVIDED A DAILY PROGRAM OF PHYSICAL ACTIVITY TOTALING 150 3 MINUTES A WEEK AS PROVIDED IN THIS SUBSECTION:
- 4 (I) THE PROGRAM SHALL INCLUDE A MINIMUM OF 90 5 MINUTES A WEEK OF PHYSICAL EDUCATION; AND
- 6 (II) ANY MINUTES NOT CONSISTING OF PHYSICAL 7 EDUCATION SHALL CONSIST OF DEVELOPMENTALLY APPROPRIATE, MODERATE 8 TO VIGOROUS ACTIVITY, INCLUDING RECESS.
- 9 (2) As APPLICABLE, A STUDENT'S PROGRAM OF PHYSICAL 10 ACTIVITY SHALL BE CONSISTENT WITH THE STUDENT'S INDIVIDUALIZED 11 EDUCATION PLAN (IEP).
- 12 (3) EACH PUBLIC ELEMENTARY SCHOOL SHALL DESIGNATE A
  13 PHYSICAL ACTIVITY LEADERSHIP TEAM TO PLAN AND COORDINATE
  14 OPPORTUNITIES FOR ACTIVITIES THAT MEET THE REQUIREMENTS OF
  15 PARAGRAPH (1)(II) OF THIS SUBSECTION.
- 16 (C) A STUDENT IN A PUBLIC HIGH SCHOOL SHALL COMPLETE TWO
  17 YEARS OF PHYSICAL EDUCATION IN ORDER TO GRADUATE FROM A PUBLIC HIGH
  18 SCHOOL.
- 19 (D) THE STATE BOARD SHALL ADOPT REGULATIONS NECESSARY TO 20 IMPLEMENT THE PROVISIONS OF THIS SECTION.
- 21 [(b)] **(E)** The Department shall employ a full–time director of physical 22 education.
- SECTION 2. AND BE IT FURTHER ENACTED, That any county school system that does not meet the requirements of this Act by October 1, 2008 may apply to the State Department of Education for an extension on compliance with this Act. If granted, an extension shall terminate at the end of July 1, 2011.
- SECTION 3. AND BE IT FURTHER ENACTED, That a county school system that receives an extension under Section 2 of the Act shall have a plan to ensure the county school system's full compliance with the requirements of this Act by July 1, 30 2011.
- SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2008.
