1 AN ACT concerning

2 **Home Builders – Sales Representative Registration and Home Builder**
3 **Guaranty Fund**

4 FOR the purpose of repealing a requirement that an individual who sells any real
5 estate as a sales agent for a home builder be licensed by the State Real Estate
6 Commission; renaming the Home Builder Registration Unit in the Consumer
7 Protection Division of the Office of the Attorney General to be the Home Builder
8 and Home Builder Sales Representative Registration Unit; requiring the Unit to
9 maintain a list of certain registered sales representatives; requiring the Unit to
10 make certain information regarding certain laws and regulations available to
11 certain registered sales representatives within a certain time period; requiring
12 the Unit to collect and maintain certain information regarding consumer
13 complaints involving registered sales representatives; prohibiting certain
14 persons from acting as home builder sales representatives unless the person is a
15 registered sales representatives; providing for certain application, issuance, and

3 certain registration certificate in a certain manner; requiring certain home
4 builders to disclose certain information to a prospective home buyer;
5 authorizing the Unit to deny, reprimand, suspend, or revoke a certain
6 registration certificate or impose certain penalties on certain registered sales
7 representatives under certain circumstances; prohibiting certain acts and

26 security plan to file a certain claim with the plan and exhaust the plan's claims

30 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
31 MARYLAND, That the Laws of Maryland read as follows:

32 **Article – Business Occupations and Professions**

33 17-101.

34 (a) In this title the following words have the meanings indicated.

35 (l) “Provide real estate brokerage services” means to engage in any of the
36 following activities:

1 (1) for consideration, providing any of the following services for
2 another person:

3 (i) selling, buying, exchanging, or leasing any real estate; **OR**

4 (ii) [selling any real estate as a sales agent for a home builder;
5 or

6 (iii)] collecting rent for the use of any real estate;

7 (2) for consideration, assisting another person to locate or obtain for
8 purchase or lease any residential real estate;

9 (3) engaging regularly in a business of dealing in real estate or leases
10 or options on real estate;

11 (4) engaging in a business the primary purpose of which is promoting
12 the sale of real estate through a listing in a publication issued primarily for the
13 promotion of real estate sales;

14 (5) engaging in a business that subdivides land that is located in any
15 state and sells the divided lots; or

16 (6) for consideration, serving as a consultant regarding any activity
17 set forth in items (1) through (5) of this subsection.

20 (a) In this title the following words have the meanings indicated.

21 (b) “Consumer” means an owner or a contract purchaser.

22 (c) “Contract purchaser” means a person who has entered into a contract
23 with a home builder to purchase a new home, but who has not yet settled on the
24 purchase of the new home.

25 (d) “Division” means the Consumer Protection Division of the Office of the
26 Attorney General.

27 (e) “Exempt lender” means a lender exempt from the requirements of
28 registration as provided in § 4.5–501(c) of this title.

29 (f) **“GUARANTY FUND” MEANS THE HOME BUILDER GUARANTY FUND.**

1 [(f)] (G) (1) “Home builder” means a person that undertakes to erect or
2 otherwise construct a new home.

3 (2) “Home builder” includes:

4 (i) a custom home builder as defined in § 10–501 of the Real
5 Property Article;

6 (ii) a new home builder subject to § 10–301 of the Real Property
7 Article; and

8 (iii) the installer or retailer of a mobile home or an industrialized
9 building intended for residential use.

10 (3) “Home builder” does not include:

11 (i) an employee of a registrant who does not hold himself or
12 herself out for hire in home building except as an employee of a registrant;

13 (ii) subcontractors or other vendors hired by the registrant to
14 perform services or supply materials for the construction of a new home who do not
15 otherwise meet the requirements of this title;

16 (iii) the manufacturer of industrialized buildings intended for
17 residential use or of mobile homes, unless the manufacturer also installs the
18 industrialized buildings or mobile homes;

19 (iv) a real estate developer who does not construct homes;

20 (v) a financial institution that lends funds for the construction
21 or purchase of residential dwellings in the State; or

22 (vi) **EXCEPT AS OTHERWISE PROVIDED IN THIS TITLE**, a
23 person who erects or constructs new homes solely in Montgomery County.

24 [(g)] (H) “Home builder registration number” means a registration number
25 issued by the Unit to a registrant under this title.

26 (I) (1) **“HOME BUILDER SALES REPRESENTATIVE” MEANS AN
27 INDIVIDUAL EMPLOYED BY A HOME BUILDER AS THE HOME BUILDER’S
28 REPRESENTATIVE TO CONSUMERS REGARDING THE PURCHASE OF A NEW HOME
29 FROM THE HOME BUILDER.**

30 (2) **“HOME BUILDER SALES REPRESENTATIVE” INCLUDES
31 INDIVIDUALS EMPLOYED BY A PERSON WHO ERECTS OR CONSTRUCTS NEW**

1 HOMES SOLELY IN MONTGOMERY COUNTY AND IS NOT REQUIRED TO REGISTER
2 UNDER THIS TITLE.

3 (3) "HOME BUILDER SALES REPRESENTATIVE" DOES NOT
4 INCLUDE:

5 (I) AN INDIVIDUAL EMPLOYED BY AN INSTALLER OR
6 RETAILER OF MOBILE HOMES OR INDUSTRIALIZED BUILDINGS INTENDED FOR
7 RESIDENTIAL USE; OR

8 (II) AN EMPLOYEE OR OFFICER AGENT FOR A NONPROFIT
9 ORGANIZATION, WITH AT LEAST A ~~5-YEAR-EXEMPLARY~~ 2-YEAR RECORD IN THE
10 STATE AS A DEVELOPER OF AFFORDABLE HOUSING FOR PERSONS WITH LOW TO
11 MODERATE INCOMES, IN THE INITIAL SALE OF A HOME IF:

12 1. THE HOME IS CONSTRUCTED OR REHABILITATED
13 BY THE NONPROFIT ORGANIZATION; AND

14 2. THE PURCHASER OF THE HOME IS USING
15 FEDERAL, STATE, OR LOCAL GOVERNMENT OR OTHER SUBSIDIZED FINANCING
16 ADMINISTERED BY THE NONPROFIT ORGANIZATION FOR THE PURPOSE OF
17 ASSISTING INDIVIDUALS WITH LOW TO MODERATE INCOMES TO PURCHASE
18 HOMES.

19 [(h)] (J) "Industrialized building" has the meaning stated in § 12-301 of the
20 Public Safety Article.

21 [(i)] (K) "Install" has the meaning stated in § 12-301 of the Public Safety
22 Article.

23 [(j)] (L) "Mobile home" means a manufactured home as defined in § 12-301
24 of the Public Safety Article.

25 [(k)] (M) (1) "New home" means each newly constructed residential
26 dwelling unit in the State and the fixtures and structure that are made a part of a
27 newly constructed private dwelling unit at the time of construction.

28 (2) "New home" includes:

29 (i) a custom home as defined in § 10-501(c) of the Real Property
30 Article;

31 (ii) a new home to which § 10-301 of the Real Property Article
32 applies;

- 1 (iii) an industrialized building intended for residential use; and
2 (iv) a mobile home.

3 (N) **“NEW HOME CONTRACT” MEANS AN AGREEMENT BETWEEN A HOME**
4 **BUILDER AND A CONSUMER FOR THE SALE OR CONSTRUCTION OF A NEW HOME.**

5 [(1)] (O) (1) “Owner” means a person for whom a new home is built or to
6 whom a new home is sold for occupation by:

7 (i) that person or the family of that person as a home; or

8 (ii) the successors of that person in title to the home or a
9 mortgagor in possession.

10 (2) “Owner” includes a contract purchaser who contracts with a
11 registrant for the construction and purchase of a new home.

12 (3) “Owner” does not include:

13 (i) a development company, association, or subsidiary company
14 of a registrant; or

15 (ii) a person or organization to whom the home may be conveyed
16 by the registrant for a purpose other than residential occupation by that person or
17 organization.

18 [(m)] (P) “Principal” means:

19 (1) a sole proprietor, officer, director, general partner, or limited
20 liability company manager of an applicant or registrant;

21 (2) a person with at least 10 percent ownership in an applicant or
22 registrant or a subsidiary of an applicant or registrant; and

23 (3) parents, spouses, and children with a combined 10 percent
24 ownership in an applicant or registrant or a subsidiary of an applicant or registrant.

25 (Q) **“REGISTERED SALES REPRESENTATIVE” MEANS A PERSON**
26 **REGISTERED TO BE A HOME BUILDER SALES REPRESENTATIVE UNDER THIS**
27 **TITLE.**

28 [(n)] (R) “Registrant” means a person registered to build new homes.

29 (S) **“REGISTRATION CERTIFICATE” MEANS A CERTIFICATE ISSUED TO A**
30 **REGISTERED SALES REPRESENTATIVE BY THE UNIT.**

1 [(o)] (T) “Registration Fund” means the Home Builder Registration Fund.

3 There is a Home Builder **AND HOME BUILDER SALES REPRESENTATIVE**
4 Registration Unit in the Division.

5 4.5–202.

6 (a) The Unit shall maintain a list of all registrants **AND REGISTERED**
7 **SALES REPRESENTATIVES.**

8 (b) (1) The Unit shall make available to each applicant for registration **AS**
9 **A HOME BUILDER OR HOME BUILDER SALES REPRESENTATIVE** a copy of this title
10 and other applicable laws and regulations.

11 (2) The Unit shall make available to each registrant **AND EACH**
12 **REGISTERED SALES REPRESENTATIVE** any amendments to this title or other
13 applicable laws or regulations at least 30 days before the effective date of the
14 amendments.

15 (c) (1) In consultation with the home building industry, the Unit shall
16 develop a consumer information pamphlet written in plain English that describes:

17 (i) the rights and remedies of consumers in the purchase of a
18 new home; and

19 (ii) any other information that the Division considers reasonably
20 necessary to assist consumers.

21 (2) The Division shall provide each registered home builder with a
22 sufficient number of copies of the consumer information pamphlets as needed by the
23 home builder.

24 (3) A home builder shall provide each contract purchaser with the
25 consumer information pamphlet before entering into a contract for the initial sale of a
26 new home.

27 (4) The contract purchaser shall acknowledge in writing the receipt of
28 the consumer information pamphlet.

29 (5) The failure of a home builder to provide a copy of the consumer
30 protection pamphlet to a contract purchaser may not be used as a basis for
31 invalidation of the contract for the initial sale of a new home.

1 (d) The Unit shall collect and maintain information on the resolution of
2 consumer complaints involving new home builders **OR HOME BUILDER SALES**
3 **REPRESENTATIVES.**

4 4.5–203.

5 (a) (1) There is a Home Builder Registration Fund.

6 (2) The Division shall administer the Registration Fund.

7 (3) The Registration Fund shall be used to cover the actual
8 documented direct and indirect costs incurred for the administration and enforcement
9 of the Maryland Home Builder Registration Act.

10 (4) The Registration Fund is a continuing, nonlapsing fund, and is
11 subject to § 7–302 of the State Finance and Procurement Article.

12 (5) Unspent assets of the Registration Fund shall remain in the
13 Registration Fund and may not revert or be transferred to the General Fund of the
14 State.

15 (6) The Registration Fund may not be supported by appropriations of
16 State funds.

17 (b) The Division shall pay all funds collected under §§ 4.5–303, 4.5–304, and
18 4.5–305 of this title to the Comptroller, who shall distribute the fees to the
19 Registration Fund.

20 (c) The Office of Legislative Audits shall audit the accounts and transactions
21 of the Registration Fund under § 2–1220 of the State Government Article.

22 4.5–301.

23 (A) Except as otherwise provided in this title, a person may not act as a home
24 builder in the State unless the person is registered as a home builder under this title.

25 (B) **A PERSON MAY NOT ACT AS A HOME BUILDER SALES**
26 **REPRESENTATIVE IN THE STATE UNLESS THE PERSON IS A REGISTERED SALES**
27 **REPRESENTATIVE UNDER THIS TITLE.**

28 4.5–302.

29 (a) Each person that constructs new homes for sale to the public shall
30 maintain general liability insurance for at least \$100,000.

1 (b) If a home builder's registration has been revoked and the home builder
2 applies for a new registration, the Unit shall, in its discretion, approve the application
3 on the applicant's fulfillment of specified terms and conditions, including the posting
4 of a bond for the benefit of subcontractors, suppliers, and consumers, and the payment
5 of any judgments or awards due to any subcontractors, suppliers, and consumers, for a
6 period of 4 years from the date of the approval of registration, after which the
7 licensing bond shall expire and shall no longer be required to be maintained by the
8 registered home builder.

9 4.5-303.

10 (a) To apply for registration **AS A HOME BUILDER OR A HOME BUILDER**
11 **SALES REPRESENTATIVE**, an applicant shall:

12 (1) submit to the Unit under oath an application on the form provided
13 by the Unit; and

14 (2) pay the nonrefundable application fee required by this subtitle.

15 (b) The application **FOR REGISTRATION AS A HOME BUILDER** shall require
16 an applicant to provide:

17 (1) the applicant's name;

18 (2) the applicant's business address, telephone number, and, if
19 applicable, electronic mail address;

20 (3) in the case of an applicant who is an individual, the applicant's
21 Social Security number;

22 (4) in the case of an applicant other than an individual:

23 (i) the applicant's federal employer identification number; and

24 (ii) the names and addresses of all principals of the applicant;

25 (5) the names of all applicants and principals who have previously
26 applied for registration, and the disposition of all previous applications;

27 (6) the name of any applicant or principal that was a principal in an
28 entity that previously applied for registration;

29 (7) a list of all states and other jurisdictions in which the applicant
30 holds a similar registration or license;

31 (8) a list of all states and other jurisdictions in which the applicant
32 has had a similar registration or license suspended or revoked;

1 (9) a statement whether any pending judgments or tax liens exist
2 against the applicant;

3 (10) (i) the election made by the applicant regarding deposit moneys
4 under § 10–301 of the Real Property Article; and

5 (ii) if the applicant elects to hold deposits in an escrow account,
6 the account number and the name of the financial institution that holds the escrow
7 account;

8 (11) if the applicant participates in a new home warranty security plan,
9 the name and address of the warranty company; and

10 (12) the name of the insurance carrier and the policy number of the
11 general liability coverage required under § 4.5–302 of this subtitle.

12 **(C) THE APPLICATION FOR REGISTRATION AS A HOME BUILDER SALES**
13 **REPRESENTATIVE SHALL REQUIRE AN APPLICANT TO PROVIDE:**

14 **(1) THE APPLICANT’S NAME;**

15 **(2) THE APPLICANT’S BUSINESS ADDRESS, TELEPHONE NUMBER,**
16 **AND, IF APPLICABLE, ELECTRONIC MAIL ADDRESS;**

17 **(3) THE APPLICANT’S SOCIAL SECURITY NUMBER;**

18 **(4) A LIST OF ALL STATES AND OTHER JURISDICTIONS IN WHICH**
19 **THE APPLICANT HOLDS A SIMILAR REGISTRATION OR LICENSE;**

20 **(5) A LIST OF ALL STATES AND OTHER JURISDICTIONS IN WHICH**
21 **THE APPLICANT HAS HAD A SIMILAR REGISTRATION OR LICENSE SUSPENDED**
22 **OR REVOKED;**

23 **(6) THE APPLICANT’S EMPLOYER’S BUSINESS NAME, ADDRESS,**
24 **TELEPHONE NUMBER, AND REGISTRATION NUMBER OR IF THE EMPLOYER IS**
25 **EXEMPT FROM REGISTRATION UNDER THIS TITLE, DOCUMENTATION THAT THE**
26 **EMPLOYER ERECTS OR CONSTRUCTS HOMES SOLELY IN MONTGOMERY**
27 **COUNTY; AND**

28 **(7) A STATEMENT WHETHER ANY PENDING JUDGMENTS OR TAX**
29 **LIENS EXIST AGAINST THE APPLICANT.**

1 (a) The Unit shall register and issue a home builder registration number to
2 an applicant **FOR A HOME BUILDER REGISTRATION** that:

3 (1) meets the requirements of this title; and

4 (2) pays to the Division an initial nonrefundable 2-year registration
5 fee of [~~\$300~~] **\$600**.

6 (b) A **HOME BUILDER** registration issued under this title may not be
7 transferred, assigned, or pledged.

8 (c) A valid **HOME BUILDER** registration authorizes the registrant to act as a
9 home builder in the State.

10 (d) (1) A home builder that holds a license or registration in Montgomery
11 County may act as a home builder in that county only, unless the home builder is also
12 registered under this title.

13 (2) **A HOME BUILDER THAT HOLDS A LICENSE OR REGISTRATION**
14 **IN MONTGOMERY COUNTY AND IS NOT REGISTERED UNDER THIS TITLE IS**
15 **SUBJECT TO SUBTITLE 7 OF THIS TITLE.**

16 (3) (I) **IN ADDITION TO THE COUNTY LICENSE OR**
17 **REGISTRATION FEE, A HOME BUILDER THAT IS REQUIRED TO HOLD A LICENSE**
18 **OR REGISTRATION ONLY IN MONTGOMERY COUNTY SHALL PAY TO THE COUNTY**
19 **A GUARANTY FUND ADMINISTRATIVE FEE OF \$150.**

20 (II) **THE COUNTY SHALL REMIT THE GUARANTY FUND**
21 **ADMINISTRATIVE FEE TO THE UNIT TO BE DEPOSITED IN THE REGISTRATION**
22 **FUND.**

24 (A) **THE UNIT SHALL REGISTER AND ISSUE A REGISTRATION**
25 **CERTIFICATE TO AN APPLICANT FOR A HOME BUILDER SALES REPRESENTATIVE**
26 **REGISTRATION CERTIFICATE THAT:**

27 (1) **MEETS THE REQUIREMENTS OF THIS TITLE; AND**

28 (2) **PAYS TO THE DIVISION AN INITIAL NONREFUNDABLE 2-YEAR**
29 **REGISTRATION FEE OF \$200.**

30 (B) **A UNIT SHALL INCLUDE ON EACH REGISTRATION CERTIFICATE**
31 **THAT THE UNIT ISSUES:**

1 **(1) THAT THIS IS A REGISTRATION CERTIFICATE FOR A**
2 **REGISTERED SALES REPRESENTATIVE;**

3 **(2) THE FULL NAME OF THE CERTIFICATE HOLDER;**

4 **(3) THE CERTIFICATE HOLDER'S EMPLOYER'S REGISTRATION**
5 **NUMBER OR THE NAME OF THE LICENSED OR REGISTERED MONTGOMERY**
6 **COUNTY HOME BUILDER; AND**

7 **(4) THE CERTIFICATE HOLDER'S REGISTRATION NUMBER.**

8 **(C) A REGISTRATION CERTIFICATE ISSUED UNDER THIS TITLE MAY NOT**
9 **BE TRANSFERRED, ASSIGNED, OR PLEDGED.**

10 **(D) A VALID REGISTRATION CERTIFICATE AUTHORIZES THE**
11 **CERTIFICATE HOLDER TO ACT AS A HOME BUILDER SALES REPRESENTATIVE IN**
12 **THE STATE.**

13 **(E) THE UNIT MAY ISSUE A REGISTRATION CERTIFICATE TO REPLACE A**
14 **LOST, DESTROYED, OR MUTILATED REGISTRATION CERTIFICATE IF THE**
15 **CERTIFICATE HOLDER PAYS THE REGISTRATION CERTIFICATE REPLACEMENT**
16 **FEE SET BY THE UNIT.**

17 4.5-305.

18 (a) (1) Unless renewed under this section, a registration **OR**
19 **REGISTRATION CERTIFICATE** expires on the second anniversary of its effective date.

20 (2) A registrant **OR REGISTERED SALES REPRESENTATIVE** that
21 meets the requirements of subsection (c) of this section may obtain a renewal of a
22 registration **OR REGISTRATION CERTIFICATE** before the registration **OR**
23 **REGISTRATION CERTIFICATE** expires for an additional 2-year term.

24 (3) Once expired, a registration **OR A REGISTRATION CERTIFICATE**
25 may not be renewed.

26 (b) At least 60 days before a registration **OR REGISTRATION CERTIFICATE**
