FISCAL AND POLICY NOTE

Senate Bill 1003 (Senator Astle) Education, Health, and Environmental Affairs

Anne Arundel County - Alcoholic Beverages - Class H-EX Licenses

This bill establishes a Class H-EX (hotel express) beer and light wine license (on-sale or off-sale) and a Class H-EX (hotel express) beer, wine, and liquor license (on-sale) for use in a hotel in Anne Arundel County. Class H-EX licenses do not require that a hotel have a food service facility or a minimum number of rooms.

The bill takes effect June 1, 2008.

Fiscal Summary

State Effect: None.

Local Effect: Anne Arundel County revenues could increase by a minimal amount from the issuance of Class H-EX alcoholic beverages licenses. Expenditures would not be affected.

Small Business Effect: Minimal. Hotels without food service facilities could realize a positive benefit in the form of increased revenues from the sale of alcoholic beverages.

Analysis

Bill Summary: A Class H-EX alcoholic beverages license allows the licensee to sell specified alcoholic beverages to hotel guests who may consume the beverages in their rooms. The Class H-EX beer and light wine license authorizes the holder to sell unopened bottles of beer and light wine to a customer for off-site consumption. A Class H-EX beer, wine, and liquor license may not be issued in the City of Annapolis.

The annual license fee for a Class H-EX beer and light wine license is \$1,500 and the license fee for a Class H-EX beer, wine and liquor license is \$2,500. Both licenses allow Sunday sales and are exempt from any requirements on the minimum number of rooms offered or on-premise food service facilities.

Current Law: There is no alcoholic beverages license available to hotels in Anne Arundel County without food service facilities. An event organizer may acquire a one-day special event permit to be used at a hotel for up to six consecutive days.

Local Fiscal Effect: Anne Arundel County advises that board of license commissioners regularly grants special event permits to hotels without food service facilities. The daily fee for special event permits varies between \$15 and \$50, depending on the purpose of the event. Hotels typically will apply for a six-day permit at a rate of \$25 per day.

Anne Arundel County revenues from alcoholic beverages licenses would increase by either \$1,500 or \$2,500 for each Class H-EX license issued, depending on the authorized beverages. Revenues from the issuance of special event permits to hotels without dining facilities would decrease for hotels that obtain a Class H-EX license. The number of Class H-EX licenses that would be issued and the resulting reduction in special event permits issued cannot be reasonably ascertained at this time, but the net effect is expected to be minimal.
