# FISCAL AND POLICY NOTE Revised

Senate Bill 117

(Senator Stone, et al.)

#### **Baltimore County - State's Attorney - Salary**

This bill provides that beginning with the term of the State's Attorney, elected in 2010, the annual salary for the Baltimore County State's Attorney is \$194,276. Beginning January 1, 2012 and each year thereafter until January 1, 2023, the salary will increase by 1%.

The bill takes effect July 1, 2008.

#### **Fiscal Summary**

State Effect: None.

**Local Effect:** Baltimore County expenditures would decrease by \$15,300 in FY 2011 and by \$44,800 over current county practice in FY 2013. Revenues would not be affected.

Small Business Effect: None.

### **Analysis**

**Current Law:** Beginning in 1982, the salary for the Baltimore County State's Attorney is set equal to the salary of a circuit court judge, with the amount increased by 5% each year during the State Attorney's term of office.

Article III, § 35 of the Maryland Constitution prohibits the salary or compensation of any public officer from being increased or diminished during the individual's term of office, except those whose full term is fixed by law in excess of four years.

**Background:** The salary of the incumbent Baltimore County State's Attorney is currently \$194,276 for fiscal 2008. In Allegany, Calvert, Caroline, Carroll, Cecil, Charles, Dorchester, Frederick, Howard, Kent, Queen Anne's, St. Mary's, Talbot, Washington, and Wicomico counties, the salary of the State's Attorney is calculated based on a percentage of either a circuit court or District Court judge. These counties have no provisions for a salary increase during each four-year elected term. The salary for the State's Attorney is recalculated based on the salary of either the circuit or District Court judge prior to the start of each new elected term.

The annual salary amount for the State's Attorney in Harford, Prince George's, and Somerset counties is prescribed in State law. Harford County provides for an annual salary increase based on the Consumer Price Index, not to exceed 3%. In Montgomery and Garrett counties, the salary of the State's Attorney is set by each county council. In Worcester County, the State's Attorney salary is based on 90% of the salary of a District Court judge, but the county may exceed that percentage through county ordinance.

In Anne Arundel County, the salary is based on that of a circuit court judge as of December 31, 2002. Provisions for the salary increase for calendar 2004 and thereafter are based specifically on the salary of the State's Attorney for the previous calendar year. **Exhibit 1** shows the provisions for setting the salary for the State's Attorney in each county.

Full salary increases for District Court and circuit court judges as recommended by the Judicial Compensation Commission were adopted at the 2005 legislative session and are shown in **Exhibit 2**. Actual salaries for the State's Attorneys in surrounding counties for fiscal 2007 are shown in **Exhibit 3**.

**Local Fiscal Effect:** The current State's Attorney for Baltimore County was elected in 2006 and took office in January 2007. Under the interpretation of current law adopted by the Baltimore County Council, the salary of the newly elected State's Attorney was calculated in the same manner as the predecessor State's Attorney. Based on the salary of a circuit court judge in 1982, factoring in an annual increase of 5%, the State's SB 117/Page 4

Attorney for Baltimore County was paid an annual salary of \$185,025 in 2007. This salary was increased by 5% in January 2008 to equal \$194,276.

Under an alternative interpretation of current law, once elected, the State's Attorney could have received a salary equal to that of a current circuit court judge, \$128,352, to be increased by 5% in each subsequent year of the State's Attorney's term. **Exhibit 4** details the impact of the proposed legislation with respect to current practice and the impact of this proposed change on a calendar year basis. **Exhibit 5** details the impact on a fiscal year basis. Baltimore County personnel expenditures would decrease by approximately \$15,300 in fiscal 2011 over current practice, reflecting the six-month period from January through June 2011. Personnel expenditures would decrease by \$35,300 in fiscal 2012 and by \$44,800 in fiscal 2013. This estimate takes into account January 1 salary increases for the State's Attorney.
