House Bill 518 Ways and Means (Anne Arundel County Delegation)

Education, Health, and Environmental Affairs

Anne Arundel County - State Matching Stipends - National Certification

This bill establishes a State "S.T.E.M. stipend" for math, science, and technical education teachers in Anne Arundel County who are certified by the National Board for Professional Teaching Standards. The stipend is equal to one-third of the S.T.E.M. stipend provided by Anne Arundel County, up to a maximum of \$500 for each qualified teacher.

Fiscal Summary

State Effect: Assuming the county provides S.T.E.M. stipends, general fund expenditures would increase by \$5,000 in FY 2010 to pay matching stipends to 10 qualified Anne Arundel County teachers. Out-year costs reflect the assumption that two additional teachers will qualify for the increased stipend each year.

Local Effect: Potential expenditure increase of \$15,000 by Anne Arundel County in FY 2010 to provide stipends for eligible county teachers. Potential revenue increase of \$5,000 in matching funds from the State if the county opts to provide S.T.E.M. stipends to eligible county teachers.

Small Business Effect: None.

Analysis

Current Law: The Quality Teacher Incentive Act of 1999 (Chapter 600) provides a \$2,000 State match for any stipend paid by local school systems to teachers who achieve certification by the National Board for Professional Teaching Standards.

Background: The National Board for Professional Teaching Standards was founded in 1987 at the recommendation of the Carnegie Task Force on Teaching as a Profession. A core component of the board's mission is to provide a voluntary national system for certifying teachers who meet rigorous standards. National certification is designed to complement, not replace, state licensing and certification systems.

The Maryland State Department of Education reports that 822 Maryland teachers were national board-certified during the 2006-07 school year. A recent breakdown by county is not available, but Anne Arundel County reports that it has 124 teachers with national board certificates, of whom 10 teach in the designated content areas. **Exhibit 1** shows the annual stipends provided by each local school system to teachers who achieve national board certification.

State Expenditures: Anne Arundel County does not currently provide an additional stipend for science, math, and technical education teachers who are national board certified. Assuming the county agrees to provide S.T.E.M. stipends to qualifying teachers, general fund expenditures could increase by approximately \$5,000 in fiscal 2010 to provide the State match for 10 county teachers.

Local Fiscal Effect: The bill does not require Anne Arundel County to provide additional stipends to eligible teachers. However, if it chooses to pursue the available State matching funds, expenditures by the county could increase by as much as \$15,000 in fiscal 2010 for the 10 eligible teachers.
