AMENDMENTS TO HOUSE BILL 1030 (Third Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 5, after "convicted" insert "<u>on or after a certain date</u>"; in line 6, strike "<u>on or</u>"; in the same line, after "certain" insert "<u>date</u>;"; and strike beginning with "<u>date</u>" in line 6 down through "<u>date</u>;" in line 8 and substitute "<u>requiring the Department of Public Safety and Correctional Services to contact and notify certain individuals of the registration requirements under this Act;".</u>

AMENDMENT NO. 2

On page 2, strike in their entirety lines 2 through 20, inclusive, and substitute:

"(a) Notwithstanding any other provision of law to the contrary, except as provided in subsection (b) of this section, this subtitle shall be applied retroactively to include a registrant convicted of an offense committed before July 1, 1997, and who is under the custody or supervision of a supervising authority on October 1, 2001.

(b) Notwithstanding any other provision of law to the contrary, this subtitle shall be applied retroactively to a child sexual offender who committed the sexual offense on or before October 1, 1995, and who is under the custody or supervision of a supervising authority on October 1, 2001.

(C) (1) NOTWITHSTANDING ANY OTHER PROVISION OF LAW TO THE CONTRARY, THIS SUBTITLE SHALL BE APPLIED RETROACTIVELY TO INCLUDE:

(I) <u>A PERSON CONVICTED ON OR AFTER JULY 1, 1997, OF</u> <u>AN OFFENSE COMMITTED BEFORE JULY 1, 1997, FOR WHICH REGISTRATION AS</u> <u>A SEXUALLY VIOLENT PREDATOR OR SEXUALLY VIOLENT OFFENDER IS</u> <u>REQUIRED UNDER THIS SUBTITLE; AND</u>

(II) <u>A PERSON CONVICTED ON OR AFTER OCTOBER 1, 1995,</u> <u>OF AN OFFENSE COMMITTED BEFORE OCTOBER 1, 1995, FOR WHICH</u> <u>REGISTRATION AS A CHILD SEXUAL OFFENDER IS REQUIRED UNDER THIS</u> SUBTITLE.

(2) <u>THE DEPARTMENT SHALL CONTACT AND NOTIFY EACH</u> <u>PERSON WHO IS NOT UNDER THE CUSTODY OR SUPERVISION OF A SUPERVISING</u> <u>AUTHORITY ON OCTOBER 1, 2009, FOR WHOM REGISTRATION IS REQUIRED</u> <u>UNDER PARAGRAPH (1) OF THIS SUBSECTION.</u>".
