# AMENDMENTS TO SENATE BILL 500

(First Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 3, strike "Curriculum Content" and substitute "Pilot Program Course"; in line 5, after "develop" insert "and implement a certain pilot program that includes an elective course on financial literacy as a part of the county board's high school curriculum; requiring the county board to develop the"; in the same line, after "literacy" insert "as a part of the pilot program"; strike beginning with "requiring" in line 6 down through "school;" in line 7 and substitute "requiring the county board to select a certain number of high schools in the county to participate in the pilot program course; requiring the county board to submit a certain report to the Prince George's County Senate Delegation and House Delegation on or before a certain date each year; providing for the termination of this Act;"; and in line 8, after "a" insert "pilot program".

#### AMENDMENT NO. 2

On page 1, in line 19, after "DEVELOP" insert "AND IMPLEMENT A PILOT PROGRAM THAT INCLUDES A SEMESTER-LONG ELECTIVE COURSE IN FINANCIAL LITERACY AS A PART OF THE COUNTY BOARD'S HIGH SCHOOL CURRICULUM.

## (B) (1) THE COUNTY BOARD SHALL DEVELOP";

in line 20, strike "A SEMESTER-LONG" and substitute "<u>THE</u>"; in line 21, strike "(B)" and substitute "<u>(2)</u>"; strike beginning with "DEVELOPED" in line 21 down through "SECTION" in line 22; and in line 23, strike "(1)" and substitute "<u>(I)</u>".

#### AMENDMENT NO. 3

On page 2, in lines 1, 2, 4, 5, 6, 7, 8, 9, 10, and 11, strike "(2)", "(3)", "(4)", "(5)", "(6)", "(7)", "(8)", "(9)", "(10)", and "(11)", respectively, and substitute "(II)", "(III)", "(IV)", "(V)", "(V)", "(VI)", "(VII)", "(IX)", "(X)", and "(XI)", respectively; strike beginning with "IN" in line 12 down through "LITERACY." in line 13 and substitute "The county board shall select three high schools in the county to Participate in the pilot program.

SECTION 2. AND BE IT FURTHER ENACTED, That, on or before June 30 of each year, the Prince George's County Board of Education shall submit a report, in accordance with § 2–1246 of the State Government Article, to the Prince George's County Senate Delegation and House Delegation on the success of the pilot program developed and implemented under this Act.";

in line 14, strike "2." and substitute "3."; in line 15, strike "October" and substitute "July"; and in the same line, after "2009." insert "It shall remain effective for a period of 2 years and, at the end of June 30, 2011, with no further action required by the General Assembly, this Act shall be abrogated and of no further force and effect.".
