On page 5, in line 3, strike "AND"; after line 3, insert:

"(16) TO ESTABLISH STANDARDS FOR AN ELECTRONIC CONTROL DEVICE SAFETY TRAINING COURSE THAT MUST BE COMPLETED UNDER § 4–109 OF THE CRIMINAL LAW ARTICLE; AND";
