AMENDMENTS TO HOUSE BILL 572
(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 10, strike “Director” and substitute “head”.

AMENDMENT NO. 2

On page 2, in line 9, strike “GOVERNMENT, ONE” and substitute “GOVERNMENT (ONE)”; in line 10, strike “AUTHORITY” and substitute “AUTHORITY”; in the same line, in each instance, strike the bracket; in line 11, strike “THE”; in the same line, strike “, FOR VIRGINIA,”; in line 21, after “SHALL” insert “ALSO”; in line 22, strike the first “DIRECTORS” and substitute “MEMBERS”; in the same line, after “AS” insert “THE”; in line 23, strike “DIRECTOR” and substitute “DIRECTOR”; in line 27, strike “DIRECTORS” and substitute “DIRECTORS”; and in line 33, strike “GOVERNMENT” and substitute “GOVERNMENT”.

AMENDMENT NO. 3

On pages 3 and 4, strike beginning with “(1)” in line 27 on page 3 down through “KEEPS” in line 3 on page 4 and substitute “THE INSPECTOR GENERAL SHALL REPORT TO THE BOARD AND HEAD THE OFFICE OF THE INSPECTOR GENERAL, AN INDEPENDENT AND OBJECTIVE UNIT OF THE AUTHORITY THAT CONDUCTS AND SUPERVISES AUDITS, PROGRAM EVALUATIONS, AND INVESTIGATIONS RELATING TO AUTHORITY ACTIVITIES; PROMOTES ECONOMY, EFFICIENCY, AND EFFECTIVENESS IN AUTHORITY ACTIVITIES; DETECTS AND PREVENTS FRAUD AND ABUSE IN AUTHORITY ACTIVITIES; AND KEEPS”.

AMENDMENT NO. 4

On page 5, strike beginning with “IN” in line 12 down through “(2)” in line 16; in line 16, after “PAYMENTS” insert “MADE”; in the same line, strike “SIGNATORY”

and substitute "SIGNATORY"; in line 21, strike "A"; in the same line, strike "SOURCE"
and substitute "SOURCES"; and after line 21, insert:

"(2) FOR PURPOSES OF THIS PARAGRAPH (D), A "DEDICATED FUNDING SOURCE" MEANS ANY SOURCE OF FUNDING THAT IS EARMARKED OR REQUIRED UNDER STATE OR LOCAL LAW TO BE USED TO MATCH FEDERAL APPROPRIATIONS AUTHORIZED UNDER TITLE VI, § 601, P.L. 110-432 FOR PAYMENTS TO THE AUTHORITY."
