AMENDMENTS TO SENATE BILL 802 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike "and Stone" and substitute "<u>Stone, and Harris</u>"; strike beginning with "Tuition" in line 2 down through "Establishment" in line 3 and substitute "<u>Memorial Scholarship Program - Alterations</u>"; and strike beginning with "repealing" in line 4 down through "Program." in line 13 and substitute "authorizing certain persons to apply to certain postsecondary institutions for the Edward T. Conroy Memorial Scholarship Program rather than to the Office of Student Financial Assistance in the Maryland Higher Education Commission; authorizing certain postsecondary institutions to determine eligibility for the scholarships; requiring certain postsecondary institutions to report to the Commission by certain dates the number of eligible recipients for the scholarships; requiring the Commission to allocate funds to certain postsecondary institutions for eligible recipients; prohibiting the Office of Student Financial Assistance from awarding initial scholarships after a certain date; authorizing the Office to renew scholarships if the initial application occurred prior to a certain date; and generally relating to the Edward T. Conroy Memorial Scholarship Program.

BY repealing and reenacting, without amendments,

AMENDMENT NO. 2

On page 1, strike beginning with "Section(s)" in line 25 down through "repealed." in line 26.

On page 2, in line 1, strike "SECTION 2. AND BE IT FURTHER ENACTED, That"; and after line 3, insert:

"<u>18–601.</u>

(a) (1) In this section the following words have the meanings indicated.

(2) "Disabled public safety employee" means a State or local public safety employee who sustains an injury in the line of duty that:

(i) <u>Precludes the individual from continuing to serve or be</u> <u>employed as a State or local public safety employee; and</u>

(ii) In the case of a volunteer member of a fire department or ambulance or rescue company or squad, precludes the member from continuing to be employed in the nonpublic safety occupation in which the member is engaged at the time of the injury.

- (3) <u>"Surviving spouse" means a person who has not remarried.</u>
- (4) <u>"State or local public safety employee" means a person who is:</u>
 - (i) <u>A career or volunteer member of a:</u>
 - <u>1.</u> <u>Fire department;</u>
 - <u>2.</u> <u>Ambulance company or squad; or</u>
 - <u>3.</u> <u>Rescue company or squad;</u>
 - (ii) <u>A law enforcement officer;</u>
 - (iii) <u>A correctional officer; or</u>

(iv) <u>A member of the Maryland National Guard who was a</u> resident of this State at the time of death.

(5) <u>"Victim of the September 11, 2001 terrorist attacks" means a</u> <u>Maryland resident who was killed as a result of the attacks on the World Trade Center</u> <u>in New York City, the attack on the Pentagon in Virginia, or the crash of United</u> <u>Airlines Flight 93 in Pennsylvania.</u>

(b) There is a program of scholarships that are awarded **BY ELIGIBLE POSTSECONDARY INSTITUTIONS** under this section.

(c) <u>The Program is the Edward T. Conroy Memorial Scholarship Program.</u>

(d) <u>A person may apply to [the Office] AN ELIGIBLE POSTSECONDARY</u> INSTITUTION for a scholarship under this section if the person: SB0802/584137/1 Amendments to SB 802 Page 4 of 8

(1) Except as provided in item (3)(iii) of this subsection and subsection (e) of this section, is a resident of Maryland;

(2) (i) <u>Is accepted for admission or enrolled in the regular</u> <u>undergraduate, graduate or professional program at an eligible institution; or</u>

(ii) Is enrolled in a 2-year terminal certificate program in which the course work is acceptable for transfer credit for an accredited baccalaureate program in an eligible institution; and

(3) (i) Is at least 16 years old and a son or daughter of a member of the armed forces who:

<u>1.</u> <u>Died as a result of military service after December 7,</u> 1941;

<u>2.</u> <u>Suffered a service connected 100% permanent</u> <u>disability after December 7, 1941; or</u>

<u>3.</u> <u>Was declared to be a prisoner of war or missing in</u> action, if that occurred on or after January 1, 1960 as a result of the Vietnam conflict, and if the child was born prior to or while the parent was a prisoner of war or missing in action;

(ii) Was a prisoner of war on or after January 1, 1960 as a result of the Vietnam conflict and was a resident of this State at the time the person was declared to be a prisoner of war or missing in action;

(iii) <u>1.</u> <u>A.</u> <u>Is at least 16 years old and a son or daughter of</u> <u>any State or local public safety employee killed in the line of duty; or</u>

2. Is at least 16 years old and a son or daughter of a disabled public safety employee who sustains an injury in the line of duty that renders the public safety employee 100% disabled; or

Is the surviving spouse of a disabled public safety 3. employee who sustains an injury in the line of duty that renders the public safety employee 100% disabled;

Is a veteran, as defined under § 9-901 of the State (**v**) Government Article, who:

1. Suffers a service connected disability of 25% or greater; and

Has exhausted or is no longer eligible for federal 2.veterans' educational benefits; or

Is at least 16 years old and a son or daughter of or the (vi) surviving spouse of a victim of the September 11, 2001 terrorist attacks.

(2) <u>May not:</u>

(i) Exceed the equivalent annual tuition and mandatory fees of a resident undergraduate student at the 4-year public institution of higher education within the University System of Maryland, other than the University of Maryland University College and University of Maryland, Baltimore, with the highest annual expenses for a full-time resident undergraduate; and

(ii) <u>Be less than the lesser of:</u>

<u>1.</u> <u>\$3,000; or</u>

2. The equivalent annual tuition and mandatory fees of a resident of the institution attended by the recipient of the scholarship.

(G) (1) EACH POSTSECONDARY INSTITUTION SHALL DETERMINE THE ELIGIBILITY OF PERSONS WHO APPLY TO THE INSTITUTION FOR THE EDWARD T. CONROY MEMORIAL SCHOLARSHIP PROGRAM.

(2) FUNDS FOR THE EDWARD T. CONROY MEMORIAL SCHOLARSHIP PROGRAM SHALL BE ALLOCATED BY THE COMMISSION TO EACH POSTSECONDARY INSTITUTION BASED ON THE NUMBER OF ELIGIBLE RECIPIENTS ATTENDING EACH INSTITUTION.

(3) IN OCTOBER AND FEBRUARY OF EACH YEAR, EACH POSTSECONDARY INSTITUTION SHALL REPORT TO THE COMMISSION THE NUMBER OF ELIGIBLE RECIPIENTS ATTENDING THE INSTITUTION.

(4) THE COMMISSION SHALL ALLOCATE FUNDS FOR AWARDS TO POSTSECONDARY INSTITUTIONS UPON VERIFICATION OF ELIGIBLE RECIPIENTS ATTENDING THE INSTITUTIONS. SB0802/584137/1 Amendments to SB 802 Page 7 of 8

(5) IF FUNDS CANNOT BE ALLOCATED IN THE FISCAL YEAR IN WHICH AWARDS ARE MADE, PRIORITY SHALL BE GIVEN TO ALLOCATING FUNDS FOR THOSE AWARDS IN THE FOLLOWING FISCAL YEAR.

[(g)] (H) (1) Each recipient of a scholarship under this section may hold the award for 5 years of full-time study or 8 years of part-time study.

(2) [The Office may not award more than 15 scholarships annually] THE NUMBER OF ELIGIBLE RECIPIENTS under subsection (d)(3)(v) of this section SHALL BE LIMITED TO 15 EACH YEAR.

(3) An award provided under subsection (d)(3)(vi) of this section may not exceed the amount specified in subsection (f)(2) of this section when combined with any other scholarship received by a student based on the student's status as a child or spouse of a victim of the September 11, 2001 terrorist attacks.

[(h)] (I) The Commission:

(1) May accept any gift or grant from any person for the Edward T. Conroy Scholarship Fund:

(2) Shall use any gift or grant that it receives for a scholarship from the Program; and

(3) Shall deposit any gift or grant that it receives for the Program with the State Treasurer in a nonbudgeted account.".

AMENDMENT NO. 3

AND BE IT FURTHER ENACTED</u>, That the Office of Student Financial Assistance in the Maryland Higher Education Commission may not award an initial scholarship or grant under the student financial assistance programs specified in Section 1 of this Act after June 30, 2010. The office may renew a scholarship or grant after June 30, 2010, if the individual received an initial scholarship or grant before that date.".
