On page 2, in line 7, strike "<u>The</u>" and substitute "<u>On or before September 1, 2009, the</u>"; in lines 7 and 8, strike "<u>to the General Assembly</u>"; in line 8, after the first "<u>report</u>" insert "<u>, and</u>"; in the same line, strike "<u>2009</u>" and substitute "<u>2010</u>"; in the same line, strike "<u>and</u>" and substitute "<u>shall submit</u>"; strike beginning with the second "<u>on</u>" in line 8 down through "<u>2010</u>" in line 9 and substitute "<u>to the General Assembly</u>"; in lines 11 and 12, strike "<u>and other State programs</u>"; strike beginning with "<u>In</u>" in line 27 down through "(<u>d</u>)" in line 31; in line 31, strike "<u>final report</u>" and substitute "<u>reports</u>"; in lines 32 and 33, strike "<u>: (1)</u>"; strike beginning with "<u>as</u>" in line 34 down through "<u>section</u>" in line 35; in line 36, strike "<u>Act; and</u>" and substitute "<u>section</u>."; and after line 36, insert:

"(d) <u>The stakeholder group required under subsection (c) of this section shall</u> <u>include:</u>

- (1) <u>legislators;</u>
- (2) <u>affected State agencies;</u>

(3) providers with experience in dementia, geriatrics, end-of-life care, mental health, and disabilities in younger adults;

(4) long-term care providers;

On page 3, in line 1, strike "(2)" and substitute "(e)"; in the same line, strike "provide for a" and substitute "The"; in line 2, strike "that includes" and substitute "shall include"; in lines 4 and 12, strike "(i)" and "(ii)", respectively, and substitute "(1)" and "(2)", respectively; in line 5, strike the first "of" and substitute "in"; in the same line, after the first "and" insert "in"; in line 8, strike "and other State programs"; in line 10, strike "Community Choice" and substitute "CommunityChoice"; in line 11, after "recommendations;" insert "and"; in lines 14, 17, 19, and 21, strike "1.", "2.", "3.", and "4.", respectively, and substitute "(ii)", "(iii)", "(iii)", and "(iv)", respectively; in line 20, strike "and"; and in line 25, strike "(iii)" and substitute "(v)".

On pages 3 and 4, strike in their entirety the lines beginning with line 27 on page 3 through line 5 on page 4, inclusive.

On page 4, in line 6, after "shall" insert ":

(1) include in the interim report required under subsection (a) of this section a timeline and work plan for the stakeholder process required under subsection (e) of this section; and
