(2) IS ASSOCIATED WITH AN EDUCATIONAL INSTITUTION OR A PROFESSIONAL, AMATEUR, OR RECREATIONAL SPORTS CLUB OR ATHLETIC ORGANIZATION.";
in lines 30 and 34, strike "(B)" and "(C)", respectively, and substitute "(D)" and "(E)", respectively; in lines 30 and 31, strike "OR CONDITION SUSTAINED BY AN INDIVIDUAL"; in line 31, strike "THE INDIVIDUAL'S" and substitute "AN ATHLETE'S"; and in lines 32 and 33, strike "SPORTS, GAMES, RECREATION, EXERCISE, OR OTHER ACTIVITIES" and substitute "AN ATHLETIC ACTIVITY".

On page 3 , in lines $1,3,6,8,10$, and 13 , strike "(D)", "(E)", "(F)", "(G)", "(H)", and "(I)", respectively, and substitute "(F)", "(G)", "(H)", "(I)","(J)", and "(K)", respectively.
