AMENDMENTS TO HOUSE BILL 723

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, strike “and Cardin” and substitute “Cardin, Frick, and Ivey”; strike beginning with “Authority” in line 2 down through “Disbursement” in line 3 and substitute “Officers Authorized to Perform Duties of Treasurer”; strike beginning with “providing” in line 4 down through “may” in line 5 and substitute “repealing the office of subtreasurer of a campaign finance entity; authorizing the chairman of a campaign finance entity to”; in line 6, strike “the chairman” and substitute “a chairman who makes a disbursement”; in line 7, after “entity” insert “within a certain number of days after the occurrence of certain events”; and strike beginning with “the” in line 8 down through “entity” in line 9 and substitute “officers of a campaign finance entity who are authorized to perform the duties of the treasurer”.

AMENDMENT NO. 2

On page 3, strike beginning with “**THIS**” in line 20 down through “**(2)**” in line 24; in line 27, strike “**(3) IF**” and substitute “**(2) EXCEPT AS PROVIDED IN PARAGRAPH (3) OF THIS SUBSECTION, IF**”; strike beginning with the first “**THE**” in line 28 down through “**OFFICE**” in line 29 and substitute “**MAKING THE DISBURSEMENT**”; and strike beginning with “**ALL**” in line 31 down through “**INCURRED**” in line 32 and substitute “**THE EXPENDITURE MADE**”.

On page 4, in lines 1, 3, and 5, in each instance, strike “**EACH**” and substitute “**THE**”; in line 1, strike “**AN**” and substitute “**THE**”; and after line 6, insert:

“(3) (I) IF THE TREASURER IS TEMPORARILY UNABLE TO PERFORM THE DUTIES OF THE OFFICE AT THE TIME THE CHAIRMAN MAKES A

(Over)

DISBURSEMENT UNDER THIS SUBSECTION, THE CHAIRMAN SHALL SUBMIT A REPORT TO THE TREASURER FOR THE ACCOUNT BOOK OF THE CAMPAIGN FINANCE ENTITY WITHIN 7 DAYS AFTER THE TREASURER RESUMES THE DUTIES OF THE OFFICE.

(II) THE REPORT SHALL INCLUDE THE INFORMATION REQUIRED UNDER PARAGRAPH (2) OF THIS SUBSECTION FOR EACH EXPENDITURE MADE UNDER THE AUTHORITY OF THE CHAIRMAN DURING THE PERIOD THAT THE TREASURER WAS UNABLE TO PERFORM THE DUTIES OF THE OFFICE.”.
