AMENDMENT NO. 1

On page 1, in line 3, strike "- Extension of Termination Date"; strike beginning with "codifying" in line 4 down through "provided" in line 5 and substitute "reestablishing the Commission on the Establishment of a Maryland Women in Military Service Monument; providing"; strike beginning with "on" in line 5 down through "Monument" in line 6; in line 7, strike "date for" and substitute "of"; strike beginning with "repealing" in line 7 down through "Act" in line 9 and substitute "stating the intent of the General Assembly"; and strike in their entirety lines 17 through 22, inclusive.

AMENDMENT NO. 2

On page 2, in line 18, strike "**2006**" and substitute "**2009**"; and in line 28, after "**COMPENSATION**" insert "**AS A MEMBER OF THE COMMISSION**".

On page 3, in line 8, strike "AND"; in line 9, strike "IDENTIFY AND RECOMMEND" and substitute "MONITOR COMPLIANCE WITH THE RECOMMENDATIONS MADE IN REPORTS OF THE COMMISSION ISSUED UNDER CHAPTERS 281 AND 282 OF THE ACTS OF THE GENERAL ASSEMBLY OF 2006 REGARDING"; in line 12, after "AMERICA" insert "; AND

(3) COORDINATE AND MONITOR THE EFFORT TO ERECT THE MARYLAND WOMEN IN MILITARY SERVICE MONUMENT DESCRIBED IN ITEM (2) OF THIS SUBSECTION";

strike in their entirety lines 13 through 16, inclusive; in line 17, strike "(H)" and substitute "(G)"; in the same line, strike "FINDINGS" and substitute "ACTIVITIES,

<u>SERVICE MONUMENT</u>"; in line 18, after the first "AND" insert "ANY ADDITIONAL"; and strike in their entirety lines 21 through 30, inclusive.

AMENDMENT NO. 3

On page 3, after line 30, insert:

"SECTION 2. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly, That:

- (1) The Governor appoint to the Commission on the Establishment of a Maryland Women in Military Service Monument those individuals who formerly were appointed to the predecessor Commission established under Chapters 281 and 282 of the Acts of the General Assembly of 2006 and who were serving on the Commission as of September 30, 2007; and
- (2) Notwithstanding Section 3 of this Act, if a monument to honor Maryland women in military service is completed and erected before the termination of this Act, the Commission established under this Act shall terminate its operations and cease to meet after that monument is erected.";

and in line 31, strike "2." and substitute "3.".

On pages 3 and 4, strike beginning with "However" in line 34 on page 3 down through "occurrence." in line 2 on page 4.
