On page 2, strike beginning with "ANY" in line 33 down through "COMMISSIONER" in line 34 and substitute "A CHANGE IN THE CONDITION OF THE RISK THAT RESULTS IN AN INCREASE IN THE HAZARD INSURED AGAINST;

(II) FOR NONPAYMENT OF PREMIUM;

(II) FOR NONPAYMENT OF PREMIUM; OR

- (III) <u>DUE TO THE REVOCATION OR SUSPENSION OF THE</u>
 DRIVER'S LICENSE OR MOTOR VEHICLE REGISTRATION:
