- (a) In this title the following words have the meanings indicated.
- (b) <u>"Board" means the State Board of Nursing.</u>

(c) <u>"License" means, unless the context requires otherwise, a license issued</u> by the Board to practice:

(1) <u>Registered nursing; or</u>

(2) Licensed practical nursing.

(d) <u>"Licensed practical nurse" means, unless the context requires otherwise,</u> <u>an individual who is licensed by the Board to practice licensed practical nursing.</u>

(E) <u>"LICENSURE BY ENDORSEMENT" MEANS A LICENSE ISSUED BY THE</u> BOARD, WITHOUT EXAMINATION, TO AN APPLICANT WHO IS ALREADY LICENSED IN ANOTHER STATE OR COUNTRY AND WHO THE BOARD HAS DETERMINED:

(1) <u>MEETS THE QUALIFICATIONS REQUIRED OF LICENSED</u> NURSES IN THE STATE AT THE TIME OF GRADUATION;

(2) HAS TAKEN AND PASSED AN EXAMINATION IN ANOTHER STATE OR COUNTRY THAT IS THE SAME AS, OR SUBSTANTIALLY EQUIVALENT TO, THE EXAMINATION REQUIRED UNDER THIS SUBTITLE; AND

(3) HAS AN ACTIVE, UNENCUMBERED LICENSE.

[(e)] (F) <u>"Practice licensed practical nursing" means to perform in a team</u> relationship an act that requires specialized knowledge, judgment, and skill based on principles of biological, physiological, behavioral, or sociological science to:

- (1) Administer treatment or medication to an individual;
- (2) Aid in the rehabilitation of an individual;
- (3) Promote preventive measures in community health;
- (4) <u>Give counsel to an individual;</u>
- (5) Safeguard life and health;

(6) <u>Teach or supervise; or</u>

(7) <u>Perform any additional acts authorized by the Board under § 8–</u> 205 of this title.

[(f)] (G) (1) "Practice registered nursing" means the performance of acts requiring substantial specialized knowledge, judgment and skill based on the biological, physiological, behavioral or sociological sciences as the basis for assessment, nursing diagnosis, planning, implementation and evaluation of the practice of nursing in order to:

- (i) <u>Maintain health;</u>
- (ii) Prevent illness; or
- (iii) Care for or rehabilitate the ill, injured, or infirm.
- (2) For these purposes, "practice registered nursing" includes:
 - (i) <u>Administration;</u>
 - (ii) <u>Teaching;</u>
 - (iii) <u>Counseling;</u>
 - (iv) Supervision, delegation and evaluation of nursing practice;

(v) <u>Execution of therapeutic regimen, including the</u> <u>administration of medication and treatment;</u>

(vi) Independent nursing functions and delegated medical functions; and

(vii) <u>Performance of additional acts authorized by the Board</u> <u>under § 8–205 of this title.</u>

[(g)] (H) <u>"Registered nurse" means, unless the context requires otherwise,</u> an individual who is licensed by the Board to practice registered nursing.".
