AMENDMENT NO. 1

On page 1, in line 3, strike "- Extension of Termination Date"; strike beginning with "codifying" in line 4 down through "provided" in line 5 and substitute "<u>re-establishing the Commission on the Establishment of a Maryland Women in Military Service Monument; providing</u>"; strike beginning with "on" in line 5 down through "Monument" in line 6 and substitute "<u>: authorizing the Commission to enter into a written agreement or memorandum of understanding regarding the funding, design, construction, or placement of an appropriate monument with certain government <u>entities</u>"; in line 7, strike "date for" and substitute "<u>of</u>"; strike beginning with "repealing" in line 7 down through "Act" in line 9 and substitute "<u>stating the intent of the General Assembly</u>"; and strike in their entirety lines 17 through 22, inclusive.</u>

AMENDMENT NO. 2

On page 2, in line 19, strike "2006" and substitute "2009".

On page 3, in line 1, after "COMPENSATION" insert "AS A MEMBER OF THE <u>COMMISSION</u>"; in line 9, strike "AND"; in line 10, strike "IDENTIFY AND RECOMMEND" and substitute "<u>MONITOR COMPLIANCE WITH THE</u> <u>RECOMMENDATIONS MADE IN REPORTS OF THE COMMISSION ISSUED UNDER</u> <u>CHAPTERS 281 AND 282 OF THE ACTS OF THE GENERAL ASSEMBLY OF 2006</u> <u>REGARDING</u>"; in line 13, after "AMERICA" insert "<u>; AND</u>

(3) <u>COORDINATE AND MONITOR THE EFFORT TO ERECT THE</u> MARYLAND WOMEN IN MILITARY SERVICE MONUMENT DESCRIBED IN ITEM (2) <u>OF THIS SUBSECTION.</u> EHE

(G) <u>THE COMMISSION MAY ENTER INTO A WRITTEN AGREEMENT OR</u> <u>MEMORANDUM OF UNDERSTANDING REGARDING THE FUNDING, DESIGN,</u> <u>CONSTRUCTION, OR PLACEMENT OF AN APPROPRIATE MONUMENT WITH OTHER</u> <u>GOVERNMENT ENTITIES, INCLUDING THE FEDERAL GOVERNMENT, A UNIT OF</u> <u>STATE GOVERNMENT, A COUNTY, OR A MUNICIPALITY</u>";

strike in their entirety lines 14 through 17, inclusive; in line 18, strike "FINDINGS" and substitute "ACTIVITIES, INCLUDING A REPORT ON THE STATUS OF THE MARYLAND WOMEN IN MILITARY SERVICE MONUMENT"; in line 19, after the first "AND" insert "ANY ADDITIONAL"; and strike in their entirety lines 22 through 31, inclusive.

AMENDMENT NO. 3

On page 3, after line 31, insert:

"<u>SECTION 2. AND BE IT FURTHER ENACTED</u>, That it is the intent of the <u>General Assembly that:</u>

(1) The Governor appoint to the Commission on the Establishment of a Maryland Women in Military Service Monument those individuals who formerly were appointed to the predecessor Commission established under Chapters 281 and 282 of the Acts of the General Assembly of 2006 and who were serving on the Commission as of September 30, 2007; and

(2) Notwithstanding Section 3 of this Act, if a monument to honor Maryland women in military service is completed and erected before the termination of this Act, the Commission established under this Act shall terminate its operations and cease to meet after that monument is erected.";

and in line 32, strike "2." and substitute "3.".
