AMENDMENT NO. 1

On page 1, strike beginning with "authorizing" in line 8 down through "circumstances;" in line 12; in line 14, after "level;" insert "repealing a certain requirement that the Standard Plan include certain uniform deductibles and cost sharing; requiring the Commission to specify certain deductibles and cost—sharing;"; and strike beginning with "providing" in line 16 down through "plans;" in line 22.

On page 2, strike beginning with "providing" in line 5 down through the first "Act;" in line 6; in line 6, before the second "providing" insert "providing for a delayed effective date for certain provisions of this Act;"; and in line 19, strike "15–1204(a) through (d),".

AMENDMENT NO. 2

On pages 4 and 5, strike in their entirety the lines beginning with line 23 on page 4 through line 19 on page 5, inclusive.

AMENDMENT NO. 3

On page 6, strike beginning with "The" in line 25 down through "Commission" in line 26 and substitute "THE COMMISSION SHALL SPECIFY THE DEDUCTIBLES AND COST-SHARING ASSOCIATED WITH THE BENEFITS IN THE STANDARD PLAN".

On page 7, strike beginning with "(a)" in line 4 down through "(2)" in line 7; and strike in their entirety lines 9 through 33, inclusive.

On page 8, in line 4, strike the brackets; in the same line, strike "THAT VARIES FROM"; in line 6, strike "AND HAS BEEN APPROVED BY THE COMMISSIONER"; in line 9, after "renewal;" insert "AND"; strike beginning with the semicolon in line 10 down through "limitations" in line 11; in line 16, after "renewal;" insert "AND"; strike beginning with the semicolon in line 17 down through "limitations" in line 18; in lines 21 and 22, in each instance, strike the bracket; in line 22, strike "BENEFITS THAT VARY FROM THE STANDARD PLAN"; in line 23, strike the brackets; in the same line, strike "OFFERED"; in line 30, after "renewal;" insert "AND"; and in line 31, strike "rating; and" and substitute "RATING.".

On page 9, strike line 1 in its entirety; in line 21, strike the brackets; in line 22, after "Eastern" insert "AND SOUTHERN"; and strike line 23 in its entirety.

AMENDMENT NO. 5

On page 10, in line 13, after "(1)" insert "(1)"; in line 14, strike "65%" and substitute "50%"; in line 15, strike the brackets; in the same line, strike "65%"; after line 15, insert:

"(II) BEGINNING JULY 1, 2013, BASED ON THE ADJUSTMENTS ALLOWED UNDER SUBSECTION (A)(2)(I) AND (II) OF THIS SECTION, A CARRIER MAY CHARGE A RATE THAT IS 55% ABOVE OR 55% BELOW THE COMMUNITY RATE.";

in line 20, strike "**2012**" and substitute "**2013**"; in line 23, strike the first set of brackets; in the same line, strike "**65**%"; and in line 24, strike "(1)" and substitute "(1)(1)".

in line 15, strike "6." and substitute "<u>5.</u>"; in line 18, strike "7." and substitute "<u>6.</u>"; in lines 19 and 20, in each instance, strike "October 1, 2009" and substitute "<u>July 1, 2010</u>"; strike beginning with "It" in line 20 down through "effect." in line 23; strike in their entirety lines 24 through 26, inclusive; in line 27, strike "9." and substitute "<u>7.</u>"; and in line 28, strike "6, 7, and 8" and substitute "<u>5 and 6</u>".
