AMENDMENTS TO SENATE BILL 369

(First Reading File Bill)

AMENDMENT NO. 1

On page 1, in the sponsor line, after "Stone," insert "Greenip, Brinkley, Brochin, Pipkin,"; in the same line, strike "and Simonaire" and substitute "Simonaire, Haines, and Mooney"; in lines 6 and 9, in each instance, strike "certifying" and substitute "verifying"; in line 7, after "law" insert "and that the individual has a valid Social Security number or is not eligible for a Social Security number"; in line 14, after "law;" insert "altering the expiration dates for an identification card, a moped operator's permit, and certain drivers' licenses;"; strike beginning with "requiring" in line 16 down through "Administration" in line 18 and substitute "altering a certain provision relating to an applicant for a driver's license who does not have a Social Security number to require an applicant to provide certain documentation verifying that the individual has a valid Social Security number or is not eligible for a Social Security number"; in line 19, after "application;" insert "altering certain requirements relating to renewal of a driver's license;"; in line 20, after "language;" insert "making a stylistic change;"; and in line 25, strike "(b)" and substitute "(d)".

On page 2, in line 1, strike "16-106(c)" and substitute "16-106(b) and (c)".

AMENDMENT NO. 2

On page 3 in line 4, on page 4 in line 20, on page 5 in line 9, and on page 6 in line 31, in each instance, strike "**CERTIFYING**" and substitute "**VERIFYING**".

AMENDMENT NO. 3

On page 3, in line 6, strike "AND"; in line 7, after "(5)" insert "PROVIDES DOCUMENTATION ACCEPTABLE TO THE ADMINISTRATION VERIFYING THAT THE APPLICANT:

AND

- (I) HAS A VALID SOCIAL SECURITY NUMBER; OR
- (II) IS NOT ELIGIBLE FOR A SOCIAL SECURITY NUMBER;

<u>(6)</u>";

in line 10, strike "every 5 years" and substitute "<u>AT THE END OF A PERIOD OF TIME</u> <u>DETERMINED BY THE ADMINISTRATION, BUT NOT EXCEEDING 8 YEARS</u>"; and in line 12, strike "2" and substitute "<u>5</u>".

AMENDMENT NO. 4

On page 5, in line 7, strike "AND"; in line 11, after "LAW" insert "; AND

- (4) PROVIDES DOCUMENTATION ACCEPTABLE TO THE ADMINISTRATION VERIFYING THAT THE APPLICANT:
 - (I) HAS A VALID SOCIAL SECURITY NUMBER; OR
 - (II) IS NOT ELIGIBLE FOR A SOCIAL SECURITY NUMBER";

and in line 21, strike "every 5 years" and substitute "AT THE END OF A PERIOD OF TIME DETERMINED BY THE ADMINISTRATION, BUT NOT EXCEEDING 8 YEARS".

AMENDMENT NO. 5

On page 6, in line 16, strike beginning with "Subject" through "section" and substitute "<u>IF AN APPLICANT IS ELIGIBLE FOR A SOCIAL SECURITY NUMBER</u>"; strike beginning with "(1)" in line 19 down through "number." in line 25 and substitute "<u>THE APPLICANT SHALL PROVIDE DOCUMENTATION ACCEPTABLE TO THE ADMINISTRATION VERIFYING THAT THE APPLICANT:</u>

- (1) HAS A VALID SOCIAL SECURITY NUMBER; OR
- (2) IS NOT ELIGIBLE FOR A SOCIAL SECURITY NUMBER.
- (d) The applicant shall sign the application and certify that the statements made in it are true.";

and in line 29, strike "FOR A DRIVER'S LICENSE".

AMENDMENT NO. 6

On page 7, in line 6, strike "in the fifth" and substitute "IN A YEAR DETERMINED BY THE ADMINISTRATION, BUT NOT LATER THAN THE EIGHTH"; in line 8, after "expire" insert "NOT LATER THAN"; in line 10, after "application" insert "AND ANY OTHER DOCUMENTATION REQUIRED BY THE ADMINISTRATION"; and in line 13, strike "6 months before its expiration" and substitute "A PERIOD OF TIME DETERMINED BY THE ADMINISTRATION".
