CHAPTER

1 AN ACT concerning

Election Law - Access to Voting Room and Voting Booth by Minors Not Eligible to Vote

- FOR the purpose of increasing the maximum age at which a minor may accompany a voter in the voting room and voting booth at a polling place under certain circumstances; and generally relating to access to the voting room and voting booth by minors at the polling place.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

3	(1) a voter;
4 5	(2) an individual who accompanies a voter in need of assistance in accordance with $\S 10-310(c)$ of this subtitle;
6	(3) polling place staff;
7	(4) a member or other representative of the State Board or local board;
8	(5) an accredited watcher or challenger under § 10–311 of this subtitle;
9 10	(6) an individual under the age of [13] $\bf 18$ who accompanies a voter in accordance with $\ 10-310(c)$ of this subtitle, provided that:

20 21	(c) (1) Before a voter enters a voting booth, at the request of the voter, an election judge shall:

3 4	(ii) A voter may take into the polling place any written or printed material to assist the voter in marking or preparing the ballot.
5 6 7 8	(3) (i) Except as provided in subparagraph (ii) of this paragraph, a voter who requires assistance in marking or preparing the ballot because of a physical disability or an inability to read the English language may choose any individual to assist the voter.
9 10 11	(ii) A voter may not choose the voter's employer or agent of that employer or an officer or agent of the voter's union to assist the voter in marking the ballot.
12 13 14 15	(4) If the voter requires the assistance of another in voting, but declines to select an individual to assist, an election judge, in the presence of another election judge that represents another political party, shall assist the voter in the manner prescribed by the voter.
16 17	(5) An individual assisting a voter may not suggest in any way how the voter should vote for a particular ticket, candidate, or position on a question.
18 19 20 21	(6) If a voter requires assistance under paragraph (4) or (5) of this subsection, the election judge shall record, on a form prescribed by the State Board, the name of the voter who required assistance and the name of the individual providing assistance to the voter.
22 23 24	(7) Except as provided in paragraph (3) or (4) of this subsection, an individual over the age of [12] 17 years may not accompany a voter into a voting booth.
