## A BILL ENTITLED

1 AN ACT concerning

2 **Creation of a State Debt – Maryland Consolidated Capital Bond Loan of 2009,**  
3 **and the Maryland Consolidated Capital Bond Loans of 2001, 2002, 2003, 2004,**  
4 **2005, 2006, 2007, and 2008**

5 FOR the purpose of authorizing the creation of a State Debt in the amount of One  
6 Billion, Sixty Eight Million, One Hundred Twenty Four Thousand Dollars  
7 (\$1,068,124,000), the proceeds to be used for certain necessary building,  
8 construction, demolition, planning, renovation, conversion, replacement, and  
9 capital equipment purchases of this State, for acquiring certain real estate in  
10 connection therewith, and for grants to certain subdivisions and other  
11 organizations for certain development and improvement purposes, subject to the  
12 requirement that certain grantees provide and expend certain matching funds  
13 by certain dates; imposing a certain tax on all assessable property in the State;  
14 providing generally for the issuance and sale of bonds evidencing the loan;  
15 authorizing the creation of State Debt to be issued in 2010, the proceeds to be  
16 used for certain purposes; authorizing certain unexpended appropriations in  
17 certain prior capital budgets and bond loans to be expended for other public  
18 projects; altering certain requirements for certain programs in certain prior  
19 capital budgets and bond loans; providing that the authorizations of State Debt  
20 in certain prior capital budgets and bond loans be reduced by certain amounts;  
21 providing for certain additional information to be detailed about each project in  
22 the capital program; repealing certain requirements for a certain appropriation;  
23 authorizing premiums from the sale of State bonds in certain fiscal years to  
24 remain in or be transferred to a certain fund and to be used for certain capital  
25 projects under certain circumstances; requiring the Comptroller to make certain  
26 transfers, adjustments, and reconciliations; providing for a delayed effective  
27 date for certain provisions of this Act; and generally relating to the financing of  
28 certain capital projects.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
23 MARYLAND, That:

24 (1) The Board of Public Works may borrow money and incur indebtedness on  
25 behalf of the State of Maryland through a State loan to be known as the Maryland  
26 Consolidated Capital Bond Loan of 2009 in the total principal amount of  
27 \$1,068,124,000. This loan shall be evidenced by the issuance, sale, and delivery of State  
28 general obligation bonds authorized by a resolution of the Board of Public Works and  
29 issued, sold, and delivered in accordance with §§ 8–117 through 8–124 of the State  
30 Finance and Procurement Article and Article 31, § 22 of the Code.

31 (2) The bonds to evidence this loan or installments of this loan may be sold  
32 as a single issue of bonds under § 8–122 of the State Finance and Procurement Article.

33 (3) The cash proceeds of the sale of the bonds shall be paid to the Treasurer  
34 and first shall be applied to the payment of the expenses of issuing, selling, and  
35 delivering the bonds, unless funds for this purpose are otherwise provided, and then  
36 shall be credited on the books of the Comptroller and expended, on approval by the  
37 Board of Public Works, for the following public purposes, including any applicable  
38 architects' and engineers' fees:

1 grants to the Aging Schools Program administered by the Interagency Committee for  
2 School Construction. The grants shall be allocated proportionally in accordance with §
