- FOR the purpose of requiring the Secretary of Health and Mental Hygiene to provide certain individuals with certain certificates on request; altering a provision of law to allow certain birth certificates to be issued on request of a surviving spouse; and generally relating to the issuance of birth, death, and marriage certificates.

- 13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
- 14 MARYLAND, That the Laws of Maryland read as follows:

- 17 (a) (1) Except as provided in subsection (b) of this section, the Secretary 18 shall provide, on request, [any person authorized by regulations adopted under this
- subtitle with a certified or abridged copy of a birth, death, or fetal death certificate
- 20 registered under this subtitle or of the certificate of a marriage performed after June
- 21 1, 1951, **TO**:
- 22 (I) AN INDIVIDUAL NAMED ON THE CERTIFICATE;

16 17 18	(3) (i) The Secretary shall provide on request, to any person authorized by regulation adopted under this subtitle, a commemorative birth certificate.
19 20	(ii) The Department shall set a fee for the commemorative birth certificate.
21	(iii) The commemorative birth certificate shall:
22 23	1. Be in a form consistent with the need to protect the integrity of vital records but suitable for display; and
24 25	2. Have the same status as evidence as the original birth certificate.
26 27 28 29 30	(iv) A portion of the funds collected under this paragraph shall go to the Department for the production costs of issuing the commemorative birth certificates. The remainder of the funds collected shall be paid into the Children's Trust Fund established under § 13–2207 of this article to provide funding for the Child Abuse and Neglect Centers of Excellence Initiative.
