Western Maryland Code Home Rule Counties - Police Departments - Local Referendum Required

4 FOR the purpose of requiring that, if the county commissioners of a code home rule 5 county in the Western Maryland class, by ordinance, create or expand a county 6 police bureau, unit, or department or authorize the appointment of individuals 7 as police officers with full law enforcement powers, or transfer certain 8 responsibilities for the county detention center from the Sheriff's Office, the 9 ordinance is to be submitted to a referendum of the legally qualified voters of 10 the county; requiring the county commissioners and the local board of elections 11 of the appropriate county to take certain actions to provide for and hold the referendum; prohibiting, under certain circumstances, the implementation of 12 certain ordinances or resolutions enacted prior to the effective date of this Act: 13 14 requiring a certain ordinance that was enacted on a certain date relating to the 15 authorization of the appointment of individuals as police officers with certain 16 powers to be submitted by the county commissioners to a referendum of the 17 legally qualified voters of the county; requiring the county commissioners and 18 the local board of elections of the appropriate county to take certain actions and 19 hold the referendum on the previously enacted ordinance; providing that the 20 Sheriff's Office of Allegany County is responsible for highway and road patrol 21 duties in the county, with certain law enforcement powers, and continuing, in a 22 certain manner, the operation of and security for the county detention center; 23 making this Act subject to a certain contingency; and generally relating to police departments in code home rule counties in the Western Maryland class and to 24 25 the Sheriff's Office in Allegany County.

- 23 and (2) the provision of adequate funding for performance of highway and road patrol
- 24 duties by the Sheriff's Office of Allegany County.

- 26 October 1, 2009.
