## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2008 - Montgomery County -**  
3 **The Arc of Montgomery County Group Homes**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2008  
5 to alter the purpose and change the location of The Arc of Montgomery County  
6 Group Homes project from Rockville to Montgomery County.

7 BY repealing and reenacting, with amendments,  
8 Chapter 336 of the Acts of the General Assembly of 2008  
9 Section 1(3) Item (ZA01) (BQ) and (ZA02) (BB)

10 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
11 MARYLAND, That the Laws of Maryland read as follows:

12 **Chapter 336 of the Acts of 2008**

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF

16 (BQ) The Arc of Montgomery County Group Homes. Provide a

18 the matching fund provided, to the Board of Directors of The  
19 Arc of Montgomery County, Inc. for the construction, repair,  
20 renovation, reconstruction, and capital equipping of [a] group  
21 [home] **HOMES**, located in [Rockville] **MONTGOMERY**  
22 **COUNTY**. Notwithstanding Section 1(5) of this Act, the  
23 matching fund may consist of in kind contributions or funds  
24 expended prior to the effective date of this Act (Montgomery  
25 County) ..... 125,000
