2 3 4 5 6 7	(i) As to the sale of any vessel by a licensed dealer or a dealer licensed by another state or a foreign country, the total purchase price, as certified by the dealer on a form acceptable to the Department, less the value of any vessel that is traded in as part of the consideration for the sale[, which trade—in value may not exceed the value for the trade—in vessel as shown in a national publication of used vessel values adopted by the Department];
8 9	(ii) As to any other vessel that is sold by any person other than a licensed dealer, the greater of:
10	1. The total purchase price; or
11	2. \$100; or
12 13	(iii) As to any other vessel that is sold by any person other than a licensed dealer, either:
14 15 16	1. The total purchase price, if verified by means of a certified bill of sale approved by the Department, in which the actual price paid for the vessel is stated; or
17 18 19	2. The valuation shown in a national publication of used vessel values adopted by the Department if a certified bill of sale does not accompany the application.
20 21 22 23	(6) "Total purchase price" means the price of a vessel, including simultaneously purchased motors, spars, sails, and accessories exclusive of trailer, agreed on by the buyer and seller, with no deduction for trade—in or other nonmonetary consideration.
24 25 26 27	(c) (1) Except as provided in $\S 8-715(d)$ of this subtitle and in subsections (e) and (f) of this section, and in addition to the fees prescribed in subsection (b) of this section, an excise tax is levied at the rate of 5% of the fair market value of the vessel on:
28 29	(i) The issuance of every original certificate of title required for a vessel under this subtitle;
30 31	(ii) The issuance of every subsequent certificate of title for the sale, resale, or transfer of the vessel;
32	(iii) The sale within the State of every other vessel; and

1 2 3 4 5 6	(2) Notwithstanding the provisions of this subsection, no tax is paid on issuance of any certificate of title if the owner of the vessel for which a certificate of title is sought was the owner of the vessel prior to June 1, 1965, or paid Maryland sales and use tax on the vessel as required by law at the time of acquisition. The Department may require the applicant for titling to submit satisfactory proof that the applicant owned the vessel prior to June 1, 1965.
