1 AN ACT concerning

2 **Tax Increment Financing and Special Taxing Districts – Transit-Oriented**
3 **Development**

4 FOR the purpose of authorizing certain counties and municipal corporations to finance
5 the costs of public improvements located in or supporting a transit-oriented
6 development and owned by the Maryland Economic Development Corporation,
7 the State, or certain other governmental units; authorizing certain counties and
8 municipal corporations to designate special taxing districts, create special funds
9 and provide for the levy of certain taxes and to pledge tax increment revenue
10 pertaining to a development district to secure payment of obligations issued by
11 the Corporation for infrastructure improvements located in or supporting a
12 transit-oriented development; authorizing certain counties and municipal
13 corporations to pledge under an agreement that amounts deposited in any
14 special fund be paid to secure bonds issued by the Corporation for certain
15 purposes; authorizing certain counties and municipal corporations through the
16 levy of certain tax revenues, to fund the costs of infrastructure improvements,
17 or operation and maintenance of those infrastructure improvements, located in
18 or supporting a transit-oriented development; authorizing certain counties and
19 municipal corporations to use certain alternative local tax revenues for tax
20 increment financing in connection with a certain transit-oriented development;
21 adding a certain county to the list of counties authorized to exercise certain
22 powers concerning the creation of special taxing districts; providing for the
23 construction of this Act; making the provisions of this Act severable; defining
24 certain terms; and generally relating to the use of special, ad valorem, tax

5 MARYLAND, That Section(s) 12–201(j), (k), (l), (m), (n), and (o), respectively, of Article
6 – Economic Development of the Annotated Code of Maryland be renumbered to be

12 (a) (1) In this section the following words have the meanings indicated.

13 (2) “Bond” means a revenue bond, note, or other similar instrument
14 issued by a municipal corporation in accordance with this section.

15 (3) “Cost” includes the cost of:

16 (i) Construction, reconstruction, and renovation, and
17 acquisition of all lands, structures, property, real or personal, rights, rights-of-way,
18 franchises, easements, and interests acquired or to be acquired by the [municipal
19 corporation] **MARYLAND ECONOMIC DEVELOPMENT CORPORATION, THE STATE,**
20 **ANY UNIT OR DEPARTMENT OR POLITICAL SUBDIVISION OF THE STATE,** or any
21 other governmental unit having jurisdiction over the infrastructure improvement;

22 (ii) All machinery and equipment including machinery and
23 equipment needed to expand or enhance municipal services to the special taxing
24 district;

25 (iii) Financing charges and interest prior to and during
26 construction, and, if deemed advisable by the municipal corporation, for a limited
27 period after completion of the construction, interest and reserves for principal and
28 interest, including costs of municipal bond insurance and any other type of financial
29 guaranty and costs of issuance;

30 (iv) Extensions, enlargements, additions, and improvements;

31 (v) Architectural, engineering, financial, and legal services;

32 (vi) Plans, specifications, studies, surveys, and estimates of cost
33 and of revenues;

1 (vii) Administrative expenses necessary or incident to
2 determining to proceed with the infrastructure improvements; and

3 (viii) Other expenses as may be necessary or incident to the
4 construction, acquisition, and financing of the infrastructure improvements.

5 **(4) “MEDCO OBLIGATION” MEANS ANY BOND, NOTE, OR OTHER**
6 **SIMILAR INSTRUMENT THAT THE MARYLAND ECONOMIC DEVELOPMENT**
7 **CORPORATION ISSUES UNDER AUTHORITY OTHER THAN THIS SECTION TO**
8 **FINANCE THE PURPOSES SPECIFIED IN SUBSECTION (B)(2) OR (D)(3) OF THIS**
9 **SECTION ONLY WITH RESPECT TO INFRASTRUCTURE IMPROVEMENTS LOCATED**
10 **IN OR SUPPORTING A TRANSIT-ORIENTED DEVELOPMENT.**

11 **(5) “TRANSIT-ORIENTED DEVELOPMENT” HAS THE MEANING**
12 **STATED IN § 7-101 OF THE TRANSPORTATION ARTICLE.**

13 (b) (1) Subject to the provisions of this section, and for the purpose stated
14 in paragraph (2) of this subsection, each municipal corporation in the State may:

15 (i) Create a special taxing district;

16 (ii) Levy ad valorem or special taxes; and

17 (iii) Issue bonds and other obligations.

18 (2) (I) The purpose of the authority granted under paragraph (1) of
19 this subsection is to provide financing, refinancing, or reimbursement for the cost of
20 the design, construction, establishment, extension, alteration, or acquisition of
21 adequate storm drainage systems, sewers, water systems, roads, bridges, culverts,
22 tunnels, streets, sidewalks, lighting, parking, parks and recreation facilities, libraries,
23 schools, and other infrastructure improvements as necessary, whether situated within
24 the special taxing district or the municipal corporation or outside of the municipal
25 corporation if notification is given to the governmental unit having jurisdiction over
26 the infrastructure improvement and if the infrastructure improvement is reasonably
27 related to other infrastructure improvements within the special taxing district, for the
28 development and utilization of the land, each with respect to any defined geographic
29 region within the municipal corporation.

30 **(II) THE AUTHORITY GRANTED UNDER PARAGRAPH (1)(I)**
31 **AND (II) OF THIS SUBSECTION ALSO MAKES AVAILABLE A SOURCE OF FUNDING**
32 **FOR PAYMENT OF COSTS OF:**

33 **1. INFRASTRUCTURE IMPROVEMENTS LOCATED IN**
34 **OR SUPPORTING A TRANSIT-ORIENTED DEVELOPMENT; AND**

1 **2. OPERATION AND MAINTENANCE OF**
2 **INFRASTRUCTURE IMPROVEMENTS LOCATED IN OR SUPPORTING A**
3 **TRANSIT-ORIENTED DEVELOPMENT.**

4 (d) (1) Bonds shall be payable from the special fund required under
5 subsection (e) of this section.

6 (2) The governing body of a municipal corporation that issues bonds
7 under this section may also:

8 (i) Establish sinking funds;

9 (ii) Establish debt service reserve funds;

10 (iii) Pledge other assets and revenues towards the payments of
11 the principal and interest; or

12 (iv) Provide for municipal bond insurance or any other type of
13 financial guaranty of the bonds.

14 (3) All proceeds received from any bonds issued and sold shall be
15 applied solely to pay the cost of infrastructure improvements, including:

16 (i) Costs of design, construction, establishment, extension,
17 alteration, or acquisition of infrastructure improvements;

18 (ii) Costs of issuing bonds;

19 (iii) Payment of the principal and interest on loans, money
20 advances, or indebtedness incurred by a municipal corporation for any of the purposes
21 stated in subsection (b)(2) of this section, including the refunding of bonds previously
22 issued under this section; and

23 (iv) Funding of a debt service reserve fund or payment of
24 interest prior to, during, or for a limited period of time after construction.

25 (e) (1) **(I)** [Before issuing these bonds, the] **THE** governing body of the
26 municipal corporation [shall] **MAY**:

27 [(i)] **1.** Designate by resolution an area or areas as a special
28 taxing district;

29 [(ii)] **2.** Subject to paragraph (2) of this subsection, adopt a
30 resolution creating a special fund with respect to the special taxing district; and

31 [(iii)] **3.** Provide for the levy of an ad valorem or special tax on
32 all real and personal property within the special taxing district at a rate or amount

21 (III) Special taxes shall be levied pursuant to subsection (n) of
 22 this section.

23 (2) The resolution creating a special fund under paragraph [(1)(ii)]

20 SIMILAR INSTRUMENT ISSUED BY THE STATE, OR ANY UNIT, DEPARTMENT, OR
21 POLITICAL SUBDIVISION OF THE STATE, THE PROCEEDS OF WHICH HAVE BEEN
22 USED FOR ANY OF THE PURPOSES SPECIFIED IN THIS SECTION; OR

23 (IV) PAID TO THE MUNICIPAL CORPORATION TO PROVIDE
24 FUNDS TO BE USED FOR ANY LEGAL PURPOSES AS THE GOVERNING BODY OF
25 THE MUNICIPAL CORPORATION MAY DETERMINE.

26 (3) (I) A MUNICIPAL CORPORATION THAT HAS CREATED A
27 SPECIAL FUND FOR A SPECIAL TAXING DISTRICT MAY PLEDGE UNDER AN
28 AGREEMENT THAT AMOUNTS DEPOSITED TO THE SPECIAL FUND SHALL, AS THE
29 GOVERNING BODY OF THE MUNICIPAL CORPORATION MAY DETERMINE, BE PAID
30 OVER TO:

31 1. SECURE PAYMENT ON MEDCO OBLIGATIONS;

32 2. PROVIDE FOR THE PAYMENT OF COSTS OF
33 INFRASTRUCTURE IMPROVEMENTS LOCATED IN OR SUPPORTING A
34 TRANSIT-ORIENTED DEVELOPMENT; AND

1 **3. PROVIDE FOR THE PAYMENT OF COSTS OF**
