Unemployment Insurance - Eligibility - Part-Time Work

3 FOR the purpose of authorizing an individual who is able to work only part time to be deemed eligible for certain benefits under certain circumstances; clarifying that 4 5 the Secretary of Labor, Licensing, and Regulation may not use the disability of a qualified individual with a disability in finding that an individual is not 6 7 available for work, actively seeking work, or eligible for benefits under this Act; providing that a part-time worker is not considered to be unemployed if the 8 9 part-time worker is working all hours for which the part-time worker is 10 available; defining a certain term; making this Act an emergency measure; and generally relating to unemployment insurance benefits for part-time workers. 11

32	(v)	"PART-TIME WORKER" MEANS AN INDIVIDUAL:

$\frac{1}{2}$	(1) WHOSE AVAILABILITY FOR WORK IS RESTRICTED TO PART-TIME WORK; AND
3 4	(2) WHO WORKS PREDOMINANTLY ON A PART-TIME BASIS THROUGHOUT THE YEAR FOR AT LEAST 15 HOURS PER WEEK.

6 7	(a) To be eligible for benefits, an individual who files a claim for benefits shall be unemployed.
8 9	(b) An individual is considered to be unemployed in any week during which the individual:
10	(1) does not perform work for which wages are payable; or
11 12 13	(2) performs less than full-time work for which wages payable are less than the weekly benefit amount that would be assigned to the individual plus allowances for dependents.

21	(i) able to work;
22	(ii) available for work; and
23	(iii) actively seeking work.

26 27 28	(i) whether the individual has made an effort that is reasonable and that would be expected of an unemployed individual who honestly is looking for work; and

3 4 5	(I) IS ELIGIBLE FOR BENEFITS UNDER § 8–803 OF THIS TITLE BASED ON WAGES THAT ARE PREDOMINANTLY EARNED FROM PART–TIME WORK;
6	(II) IS ACTIVELY SEEKING PART-TIME WORK;

18 19 20 21	(c) Notwithstanding any other provision of this section or § 8–904 or § 8–907(a) or (b) of this subtitle, an individual who otherwise is eligible to receive benefits and who is in training with the approval of the Secretary may not be denied benefits:

AND BE IT FURTHER ENACTED, That this Act is an emergency measure, is necessary for the immediate preservation of the public health or safety, has been passed by a yea and nay vote supported by three–fifths of all the members elected to each of the two Houses of the General Assembly, and shall take effect from the date it is enacted.
