A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Speed Monitoring Systems – Statewide Authorization and Use**
3 **in Highway Work Zones**

4 FOR the purpose of expanding to all counties and municipalities in the State the
5 authority to use certain speed monitoring systems to enforce certain highway
6 speed laws under certain standards and procedures; altering the speed of a
7 motor vehicle at which a speed monitoring system will produce a recorded
8 image of the vehicle; prohibiting the use of a speed monitoring system in a local
9 jurisdiction unless authorized by the governing body by ordinance or resolution
10 adopted after reasonable notice and a public hearing; requiring a county, before
11 using a speed monitoring system at certain locations, to obtain certain approval,
12 provide certain notice, and provide a municipal corporation instead of the
13 county the opportunity to use a speed monitoring system at the locations;
14 requiring certain local ordinances or resolutions to provide for the issuance of
15 warnings during a certain period for certain violations; increasing the
16 maximum speed limit for the purpose of establishing residential highways on
17 which speed laws may be enforced using speed monitoring systems; requiring a
18 local jurisdiction to publish a certain notice before activating a certain speed
19 monitoring system; requiring a certain speed monitoring system placed in a
20 certain location to be calibrated only to record images of motor vehicles
21 traveling at or above a certain speed; repealing a certain requirement that an
22 individual provide certain information to satisfy a certain evidentiary burden;
23 requiring the Chief Judge of the District Court to consult with certain agencies
24 in adopting certain procedures; clarifying that certain fines for certain motor
25 vehicle violations shall be paid to the District Court; expanding the pool of
26 entities authorized to administer a speed monitoring program; authorizing the
27 placement of certain work zone speed control systems on certain highways
28 under certain circumstances; requiring the Comptroller to distribute to the
29 State Highway Administration the revenues from civil fines collected under this
30 Act in an amount to cover the costs of implementing and administering the

work zone speed control system; limiting the issuance of citations to owners or drivers of vehicles that exceed certain speeds; requiring a work zone speed control system operator to complete certain training and follow certain procedures; requiring a work zone speed control system to undergo certain calibration; requiring the procurement of a work zone speed control system by a unit of State government to be conducted in a certain manner; requiring the State Highway Administration to place a certain road sign within a reasonable distance of a highway work zone containing a speed monitoring system; providing that certain owners or drivers of motor vehicles, recorded by a work zone speed control system while being operated in violation of certain speed limit laws, are subject to certain penalties; authorizing certain police departments to mail a certain citation to the owner of a motor vehicle; establishing certain civil penalties for a violation of certain provisions of this Act; requiring certain citations to include certain information; authorizing a police department to send a warning instead of a citation under certain circumstances; authorizing the police department to reissue a citation to the driver of a vehicle under certain circumstances; requiring certain citations to be mailed within certain time periods; requiring the District Court to prescribe a certain citation form and to indicate the amount of a certain civil penalty on the citation; establishing the standard of proof in a trial for certain violations of this Act; authorizing persons receiving certain citations to have the work zone speed control system operator be present and able to testify at trial; providing that certain persons are responsible for paying the civil penalty indicated on the citation under certain circumstances; providing that persons receiving certain citations may elect to stand trial in the District Court; establishing defenses that the District Court may consider; authorizing vehicle owners to submit a certain letter to the District Court to establish a certain defense; authorizing the Motor Vehicle Administration to impose certain penalties if the person cited for violating certain provisions of this Act fails to pay the civil penalty or contest liability; prohibiting certain violations under this Act from being considered for certain purposes; providing for the admissibility and use of certain evidence; modifying the jurisdiction of the District Court to include certain proceedings; providing for the handling of certain court costs and penalties; clarifying certain language; prohibiting an insurer from considering a certain civil penalty for purposes of reclassifying an insured; prohibiting the custodian of recorded images produced by a work zone speed control system from allowing inspection of the recorded images, subject to certain exceptions; requiring the Department of State Police and the State Highway Administration jointly to adopt regulations establishing the standards and procedures for work zone speed control systems; requiring certain State and local entities to administer and process civil citations issued under this Act in consultation with the District Court; providing that the fees of certain contractors may not be contingent on the number of citations issued or paid under this Act; requiring the issuance of warnings for a certain time period for certain violations; defining certain terms; repealing a certain definition; altering a certain definition; making certain stylistic changes; making a technical correction; restricting the use of certain revenues generated by this Act; requiring a local jurisdiction to remit revenue generated from the use of speed monitoring systems to the Comptroller for

1 deposit to the General Fund of the State if the revenue is not spent within a
2 certain period of time; requiring a political subdivision to submit a certain
3 report under certain circumstances; providing for the application of this Act;
4 providing that existing obligations or contract rights may not be impaired by
5 this Act; providing that certain provisions of this Act do not apply to certain
6 speed monitoring systems in Montgomery County; requiring certain local
7 jurisdictions to issue a certain report by a certain date; and generally relating to
8 the use of speed monitoring systems to enforce certain laws regarding the
9 operation of motor vehicles in excess of certain speed limits.

35 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
36 MARYLAND, That the Laws of Maryland read as follows:

37 **Article – Courts and Judicial Proceedings**

38 7–302.

(e) (1) A citation issued pursuant to § 21-202.1 or § 21-809 of the Transportation Article shall provide that the person receiving the citation may elect to stand trial by notifying the issuing agency of the person's intention to stand trial at least 5 days prior to the date of payment as set forth in the citation. On receipt of the notice to stand trial, the agency shall forward to the District Court having venue a copy of the citation and a copy of the notice from the person who received the citation indicating the person's intention to stand trial. On receipt thereof, the District Court shall schedule the case for trial and notify the defendant of the trial date under procedures adopted by the Chief Judge of the District Court.

(2) A citation issued as the result of a traffic control signal monitoring system or speed monitoring system controlled by a political subdivision shall provide that, in an uncontested case, the penalty shall be paid directly to that political subdivision. A citation issued as the result of a traffic control signal monitoring system controlled by a State [agency or a speed monitoring system,] **AGENCY, OR AS A RESULT OF A TRAFFIC CONTROL SIGNAL MONITORING SYSTEM OR A SPEED MONITORING SYSTEM** in a case contested in District Court, shall provide that the penalty shall be paid directly to the District Court.

(3) Civil penalties resulting from citations issued using traffic control signal monitoring systems or speed monitoring systems that are collected by the District Court shall be collected in accordance with subsection (a) of this section and distributed in accordance with § 12-118 of the Transportation Article.

(4) (I) FROM THE FINES COLLECTED BY A POLITICAL SUBDIVISION AS A RESULT OF VIOLATIONS ENFORCED BY SPEED MONITORING SYSTEMS, A POLITICAL SUBDIVISION:

1. MAY RECOVER THE COSTS OF IMPLEMENTING AND ADMINISTERING THE SPEED MONITORING SYSTEMS; AND

2. SUBJECT TO SUBPARAGRAPHS (II), (III), AND (IV) OF THIS PARAGRAPH, MAY SPEND ANY REMAINING BALANCE SOLELY FOR RELATED PUBLIC SAFETY PURPOSES, INCLUDING PEDESTRIAN SAFETY PROGRAMS.

(II) 1. IF A POLITICAL SUBDIVISION DOES NOT SPEND FUNDS ELIGIBLE TO BE SPENT IN ACCORDANCE WITH SUBPARAGRAPH (I)2 OF THIS PARAGRAPH WITHIN 2 YEARS AFTER THE END OF THE FISCAL YEAR IN WHICH THE FUNDS WERE COLLECTED, THE POLITICAL SUBDIVISION SHALL REMIT THE UNSPENT FUNDS TO THE COMPTROLLER ON AN ANNUAL BASIS.

2. THE COMPTROLLER SHALL DEPOSIT ANY MONEY REMITTED UNDER THIS SUBPARAGRAPH TO THE GENERAL FUND OF THE STATE.

(III) FUNDS SPENT IN ACCORDANCE WITH SUBPARAGRAPH (I)2 OF THIS PARAGRAPH SHALL BE USED TO SUPPLEMENT AND MAY NOT SUPPLANT EXISTING LOCAL EXPENDITURES FOR THE SAME PURPOSE.

(IV) IN ANY YEAR THAT A POLITICAL SUBDIVISION SPENDS FUNDS ELIGIBLE TO BE SPENT IN ACCORDANCE WITH SUBPARAGRAPH (I)2 OF THIS PARAGRAPH, THE POLITICAL SUBDIVISION SHALL FILE A REPORT BY DECEMBER 1 OF THAT YEAR WITH THE GOVERNOR AND, IN ACCORDANCE WITH § 2-1246 OF THE STATE GOVERNMENT ARTICLE, THE GENERAL ASSEMBLY, DETAILING THE AMOUNT AND PURPOSES OF THE EXPENDITURE.

(o) (1) In this subsection, “recorded images” has the meaning stated in § 21-202.1 or § 21-809 of the Transportation Article.

(2) Except as provided in paragraph (3) of this subsection, a custodian of recorded images produced by a traffic control signal monitoring system operated under § 21-202.1 of the Transportation Article or a speed monitoring system operated under § 21-809 of the Transportation Article shall deny inspection of the recorded images.

(3) A custodian shall allow inspection of recorded images:

(i) as required in § 21-202.1 or § 21-809 of the Transportation Article;

(ii) by any person issued a citation under § 21-202.1 or § 21-809 of the Transportation Article, or an attorney of record for the person; or

(iii) by an employee or agent of [a law enforcement] AN agency in an investigation or proceeding relating to the imposition of or indemnification from civil liability pursuant to § 21-202.1 or § 21-809 of the Transportation Article.

Article – Transportation

21-809.

(a) (1) In this section the following words have the meanings indicated.

[(2) “Local police department” means:

(i) The Montgomery County Department of Police; and

(ii) The police department of any municipal corporation in Montgomery County.]

(2) “AGENCY” MEANS:

(I) A LAW ENFORCEMENT AGENCY OF A LOCAL POLITICAL SUBDIVISION THAT IS AUTHORIZED TO ISSUE A CITATION FOR A VIOLATION OF THE MARYLAND VEHICLE LAW OR OF LOCAL TRAFFIC LAWS OR REGULATIONS; OR

(II) FOR A MUNICIPAL CORPORATION THAT DOES NOT MAINTAIN A POLICE FORCE, AN AGENCY ESTABLISHED OR DESIGNATED BY THE MUNICIPAL CORPORATION TO IMPLEMENT THIS SUBTITLE USING SPEED MONITORING SYSTEMS IN ACCORDANCE WITH THIS SECTION.

(3) (i) “Owner” means the registered owner of a motor vehicle or a lessee of a motor vehicle under a lease of 6 months or more.

(ii) “Owner” does not include:

1. A motor vehicle rental or leasing company; or
2. A holder of a special registration plate issued under Title 13, Subtitle 9, Part III of this article.

(4) “Recorded image” means an image recorded by a speed monitoring system:

(i) On:

1. A photograph;
2. A microphotograph;
3. An electronic image;
4. Videotape; or
5. Any other medium; and

(ii) Showing:

1. The rear of a motor vehicle;
2. At least two time-stamped images of the motor vehicle that include the same stationary object near the motor vehicle; and

3. On at least one image or portion of tape, a clear **AND LEGIBLE** identification of the **ENTIRE** registration plate number of the motor vehicle.

(5) “Speed monitoring system” means a device with one or more motor vehicle sensors producing recorded images of motor vehicles traveling at speeds at least **[10] 12** miles per hour above the posted speed limit.

(6) “Speed monitoring system operator” means [an individual who] **A REPRESENTATIVE OF AN AGENCY OR CONTRACTOR THAT** operates a speed monitoring system.

(b) (1) (I) **A SPEED MONITORING SYSTEM MAY NOT BE USED IN A LOCAL JURISDICTION UNDER THIS SECTION UNLESS ITS USE IS AUTHORIZED BY THE GOVERNING BODY OF THE LOCAL JURISDICTION BY LOCAL LAW ENACTED AFTER REASONABLE NOTICE AND A PUBLIC HEARING.**

(II) **BEFORE A COUNTY MAY USE A SPEED MONITORING SYSTEM ON A STATE HIGHWAY AT A LOCATION WITHIN A MUNICIPAL CORPORATION, THE COUNTY SHALL:**

1. **OBTAIN THE APPROVAL OF THE STATE HIGHWAY ADMINISTRATION;**

2. **NOTIFY THE MUNICIPAL CORPORATION OF THE STATE HIGHWAY ADMINISTRATION’S APPROVAL OF THE USE OF A SPEED MONITORING SYSTEM AT THAT LOCATION; AND**

3. **GRANT THE MUNICIPAL CORPORATION 60 DAYS FROM THE DATE OF THE COUNTY’S NOTICE TO THE MUNICIPAL CORPORATION TO ENACT AN ORDINANCE AUTHORIZING THE MUNICIPAL CORPORATION INSTEAD OF THE COUNTY TO USE A SPEED MONITORING SYSTEM AT THAT LOCATION.**

(III) **AN ORDINANCE OR RESOLUTION ADOPTED BY THE GOVERNING BODY OF A LOCAL JURISDICTION UNDER THIS PARAGRAPH SHALL PROVIDE THAT FOR A PERIOD OF AT LEAST 30 DAYS AFTER THE FIRST SPEED MONITORING SYSTEM IS PLACED IN THE LOCAL JURISDICTION, A VIOLATION RECORDED BY ANY SPEED MONITORING SYSTEM IN THE LOCAL JURISDICTION MAY BE ENFORCED ONLY BY THE ISSUANCE OF A WARNING.**

[(1)] (IV) This section applies to a violation of this subtitle [that occurs in Montgomery County] recorded by a speed monitoring system that meets the requirements of this subsection and has been placed:

1 [(i)] 1. On a highway in a residential [district] **DISTRICT**, as
2 defined in § 21–101 of this [title:

3 1. With] **TITLE, WITH** a maximum posted speed limit of
4 [35] **45** miles per [hour; and

5 2. That has a speed limit that] **HOUR, WHICH SPEED**
6 **LIMIT** was established using generally accepted traffic engineering practices; or

7 [(ii)] 2. In a school zone established under § 21–803.1 of this
8 subtitle.

9 (V) **BEFORE ACTIVATING AN UNMANNED STATIONARY**
10 **SPEED MONITORING SYSTEM, THE LOCAL JURISDICTION SHALL:**

11 1. **PUBLISH NOTICE OF THE LOCATION OF THE**
12 **SPEED MONITORING SYSTEM ON ITS WEBSITE AND IN A NEWSPAPER OF**
13 **GENERAL CIRCULATION IN THE JURISDICTION; AND**

14 2. **ENSURE THAT EACH SIGN THAT DESIGNATES A**
15 **SCHOOL ZONE INDICATES THAT SPEED MONITORING SYSTEMS ARE IN USE IN**
16 **SCHOOL ZONES.**

17 (2) (i) A speed monitoring system operator shall complete training
18 by a manufacturer of speed monitoring systems in the procedures for setting up and
19 operating the speed monitoring system.

20 (ii) The manufacturer shall issue a signed certificate to the
21 speed monitoring system operator [upon] **ON** completion of the training.

22 (iii) The certificate of training shall be admitted as evidence in
23 any court proceeding for a violation of this section.

24 (3) A speed monitoring system operator shall fill out and sign a daily
25 set-up log for a speed monitoring system that:

26 (i) States that the speed monitoring system operator
27 successfully performed the manufacturer–specified self–test of the speed monitoring
28 system prior to producing a recorded image;

29 (ii) Shall be kept on file; and

30 (iii) Shall be admitted as evidence in any court proceeding for a
31 violation of this section.

1 (4) (i) A speed monitoring system shall undergo an annual
2 calibration check performed by an independent calibration laboratory.

3 (ii) The independent calibration laboratory shall issue a signed
4 certificate of calibration after the annual calibration check[, which] **THAT**:

- 5 1. Shall be kept on file; and
- 6 2. Shall be admitted as evidence in any court proceeding
7 for a violation of this section.

8 **(5) (I) THIS PARAGRAPH DOES NOT APPLY TO A SPEED**
9 **MONITORING SYSTEM PLACED IN A SCHOOL ZONE.**

10 **(II) IF A SPEED MONITORING SYSTEM IS PLACED WITHIN**
11 **250 FEET AFTER THE LOCATION OF A SIGN DECREASING THE MAXIMUM SPEED**
12 **LIMIT ON THE HIGHWAY, THE SPEED MONITORING SYSTEM SHALL BE**
13 **CALIBRATED ONLY TO RECORD IMAGES OF MOTOR VEHICLES TRAVELING AT**
14 **SPEEDS AT LEAST 12 MILES PER HOUR ABOVE THE POSTED SPEED LIMIT IN**
15 **EFFECT BEFORE THE LOCATION OF THE SIGN.**

16 (c) (1) Unless the driver of the motor vehicle received a citation from a
17 police officer at the time of the violation, the owner or, in accordance with subsection
18 (f)(4) of this section, the driver of a motor vehicle is subject to a civil penalty if the
19 motor vehicle is recorded by a speed monitoring system while being operated in
20 violation of this subtitle.

21 (2) A civil penalty under this subsection may not exceed \$40.

22 (3) For purposes of this section, the District Court shall prescribe:

23 (i) A uniform citation form consistent with subsection (d)(1) of
24 this section and § 7-302 of the Courts Article; and

25 (ii) A civil penalty, which shall be indicated on the citation, to be
26 paid by persons who choose to prepay the civil penalty without appearing in District
27 Court.

28 (d) (1) Subject to the provisions of paragraphs (2) through (4) of this
29 subsection, [the local police department] **AN AGENCY** shall mail to [the owner,] **AN**
30 **OWNER** liable under subsection (c) of this section[,], a citation that shall include:

31 (i) The name and address of the registered owner of the vehicle;

32 (ii) The registration number of the motor vehicle involved in the
33 violation;

- 1 (iii) The violation charged;
- 2 (iv) The location where the violation occurred;
- 3 (v) The date and time of the violation;
- 4 (vi) A copy of the recorded image;
- 5 (vii) The amount of the civil penalty imposed and the date by
6 which the civil penalty should be paid;
- 7 (viii) A signed statement by a duly authorized [agent of the local
8 police department] **LAW ENFORCEMENT OFFICER EMPLOYED BY OR UNDER**
9 **CONTRACT WITH AN AGENCY** that, based on inspection of recorded images, the motor
10 vehicle was being operated in violation of this subtitle;
- 11 (ix) A statement that recorded images are evidence of a violation
12 of this subtitle;
- 13 (x) Information advising the person alleged to be liable under
14 this section of the manner and time in which liability as alleged in the citation may be
15 contested in the District Court; and
- 16 (xi) Information advising the person alleged to be liable under
17 this section that failure to pay the civil penalty or to contest liability in a timely
18 manner:
- 19 1. Is an admission of liability;
- 20 2. May result in the refusal by the Administration to
21 register the motor vehicle; and
- 22 3. May result in the suspension of the motor vehicle
23 registration.
- 24 (2) [The local police department] **AN AGENCY** may mail a warning
25 notice instead of a citation to the owner liable under subsection (c) of this section.
- 26 (3) Except as provided in subsection (f)(4) of this section, [the local
27 police department] **AN AGENCY** may not mail a citation to a person who is not an
28 owner.
- 29 (4) Except as provided in subsection (f)(4) of this section, a citation
30 issued under this section shall be mailed no later than 2 weeks after the alleged
31 violation if the vehicle is registered in this State, and 30 days after the alleged
32 violation if the vehicle is registered in another state.

(5) A person who receives a citation under paragraph (1) of this subsection may:

(i) Pay the civil penalty, in accordance with instructions on the citation, directly to the [Montgomery County Department of Finance] **POLITICAL SUBDIVISION**; or

(ii) Elect to stand trial in the District Court for the alleged violation.

(e) (1) A certificate alleging that the violation of this subtitle occurred and the requirements under subsection (b) of this section have been satisfied, sworn to, or affirmed by [a duly authorized agent of the local police department] **AN AGENT OR EMPLOYEE OF AN AGENCY**, based on inspection of recorded images produced by a speed monitoring system, shall be evidence of the facts contained in the certificate and shall be admissible in a proceeding alleging a violation under this section without the presence or testimony of the speed monitoring system operator who performed the requirements under subsection (b) of this section.

(2) If a person who received a citation under subsection (d) of this section desires the speed monitoring system operator to be present and testify at trial, the person shall notify the court and the State in writing no later than 20 days before trial.

(3) Adjudication of liability shall be based on a preponderance of evidence.

(f) (1) The District Court may consider in defense of a violation:

(i) Subject to paragraph (2) of this subsection, that the motor vehicle or the registration plates of the motor vehicle were stolen before the violation occurred and were not under the control or possession of the owner at the time of the violation;

(ii) Subject to paragraph (3) of this subsection, evidence that the person named in the citation was not operating the vehicle at the time of the violation; and

(iii) Any other issues and evidence that the District Court deems pertinent.

(2) [In order to] **TO** demonstrate that the motor vehicle or the registration plates were stolen before the violation occurred and were not under the control or possession of the owner at the time of the violation, the owner shall submit proof that a police report regarding the stolen motor vehicle or registration plates was filed in a timely manner.

(3) To satisfy the evidentiary burden under paragraph (1)(ii) of this subsection, the person named in the citation shall provide to the District Court a letter, sworn to or affirmed by the person and mailed by certified mail, return receipt requested, that:

(i) States that the person named in the citation was not operating the vehicle at the time of the violation; **AND**

(ii) [Provides the name, address, and, if possible, the driver's license identification number of the person who was operating the vehicle at the time of the violation; and

(iii)] Includes any other corroborating evidence.

(4) (i) If the District Court finds that the person named in the citation was not operating the vehicle at the time of the violation or receives evidence under paragraph (3) of this subsection identifying the person driving the vehicle at the time of the violation, the clerk of the court shall provide to the [local police department] **AGENCY ISSUING THE CITATION** a copy of any evidence substantiating who was operating the vehicle at the time of the violation.

(ii) On receipt of substantiating evidence from the District Court under subparagraph (i) of this paragraph, [the local police department] **AN AGENCY** may issue a citation as provided in subsection (d) of this section to the person who the evidence indicates was operating the vehicle at the time of the violation.

(iii) A citation issued under subparagraph (ii) of this paragraph shall be mailed no later than 2 weeks after receipt of the evidence from the District Court.

(g) If a person liable under this section does not pay the civil penalty or contest the violation, the Administration:

(1) May refuse to register or reregister the motor vehicle cited for the violation; or

(2) May suspend the registration of the motor vehicle cited for the violation.

(h) A violation for which a civil penalty is imposed under this section:

(1) Is not a moving violation for the purpose of assessing points under § 16-402 of this article;

(2) May not be recorded by the Administration on the driving record of the owner or driver of the vehicle;

(3) May be treated as a parking violation for purposes of § 26–305 of this article; and

(4) May not be considered in the provision of motor vehicle insurance coverage.

(i) In consultation with the [Montgomery County Department of Finance and the local police departments] **APPROPRIATE LOCAL GOVERNMENT AGENCIES**, the Chief Judge of the District Court shall adopt procedures for the issuance of citations, the trial of civil violations, and the collection of civil penalties under this section.

13 WERE NOT UNDER THE CONTROL OR POSSESSION OF THE OWNER AT THE TIME
14 OF THE VIOLATION, THE OWNER SHALL SUBMIT PROOF THAT A POLICE REPORT
15 REGARDING THE STOLEN MOTOR VEHICLE OR REGISTRATION PLATES WAS
16 FILED IN A TIMELY MANNER.

17 (3) TO SATISFY THE EVIDENTIARY BURDEN UNDER PARAGRAPH
18 (1)(II) OF THIS SUBSECTION, THE PERSON NAMED IN THE CITATION SHALL
19 PROVIDE TO THE DISTRICT COURT A LETTER, SWORN TO OR AFFIRMED BY THE
20 PERSON AND MAILED BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, THAT:

21 (I) STATES THAT THE PERSON NAMED IN THE CITATION

1 (III) ANY CITATION ISSUED UNDER SUBPARAGRAPH (II) OF
2 THIS PARAGRAPH SHALL BE MAILED NO LATER THAN 2 WEEKS AFTER RECEIPT
3 OF THE EVIDENCE FROM THE DISTRICT COURT.

4 (G) IF A PERSON LIABLE UNDER THIS SECTION DOES NOT PAY THE CIVIL
5 PENALTY OR CONTEST THE VIOLATION, THE ADMINISTRATION MAY:

6 (1) REFUSE TO REGISTER OR REREGISTER THE REGISTRATION
7 OF THE MOTOR VEHICLE CITED FOR THE VIOLATION; OR

8 (2) SUSPEND THE REGISTRATION OF THE MOTOR VEHICLE CITED
9 FOR THE VIOLATION.

10 (H) A VIOLATION FOR WHICH A CIVIL PENALTY IS IMPOSED UNDER THIS
11 SECTION:

12 (1) IS NOT A MOVING VIOLATION FOR THE PURPOSE OF
13 ASSESSING POINTS UNDER § 16-402 OF THIS ARTICLE;

14 (2) MAY NOT BE RECORDED BY THE ADMINISTRATION ON THE
15 DRIVING RECORD OF THE OWNER OR DRIVER OF THE VEHICLE;

16 (3) MAY BE TREATED AS A PARKING VIOLATION FOR PURPOSES
17 OF § 26-305 OF THIS ARTICLE; AND

18 (4) MAY NOT BE CONSIDERED IN THE PROVISION OF MOTOR
19 VEHICLE INSURANCE COVERAGE.

20 (I) IN CONSULTATION WITH LOCAL POLICE DEPARTMENTS AND STATE
21 POLICE DEPARTMENTS, THE CHIEF JUDGE OF THE DISTRICT COURT SHALL
22 ADOPT PROCEDURES FOR THE ISSUANCE OF CITATIONS, THE TRIAL OF CIVIL
23 VIOLATIONS, AND THE COLLECTION OF CIVIL PENALTIES UNDER THIS SECTION.

24 (J) (1) THE DEPARTMENT OF STATE POLICE OR A CONTRACTOR
25 DESIGNATED BY THE DEPARTMENT OF STATE POLICE SHALL ADMINISTER AND
26 PROCESS CIVIL CITATIONS ISSUED UNDER THIS SECTION IN COORDINATION
27 WITH THE DISTRICT COURT.

28 (2) IF A CONTRACTOR PROVIDES, DEPLOYS, OR OPERATES A
29 WORK ZONE SPEED CONTROL SYSTEM FOR A POLICE DEPARTMENT, THE
30 CONTRACTOR'S FEE MAY NOT BE CONTINGENT ON THE NUMBER OF CITATIONS
31 ISSUED OR PAID.

(K) THE DEPARTMENT OF STATE POLICE AND THE STATE HIGHWAY ADMINISTRATION JOINTLY SHALL ADOPT REGULATIONS ESTABLISHING STANDARDS AND PROCEDURES FOR WORK ZONE SPEED CONTROL SYSTEMS AUTHORIZED UNDER THIS SECTION.

26–305.

(a) The Administration may not register or transfer the registration of any vehicle involved in a parking violation under this subtitle, a violation under any federal parking regulation that applies to property in this State under the jurisdiction of the U.S. government, a violation of § 21–202(h) of this article as determined under § 21–202.1 of this article or Title 21, Subtitle 8 of this article as determined under § 21–809 **OR § 21–810** of this article, or a violation of the State litter control law or a local law or ordinance adopted by Baltimore City relating to the unlawful disposal of litter as determined under § 10–112 of the Criminal Law Article, if:

(1) It is notified by a political subdivision or authorized State agency that the person cited for the violation under this subtitle, § 21–202.1 [or], § 21–809, **OR § 21–810** of this article, or § 10–112 of the Criminal Law Article has failed to either:

(i) Pay the fine for the violation by the date specified in the citation; or

(ii) File a notice of his intention to stand trial for the violation;

(2) It is notified by the District Court that a person who has elected to stand trial for the violation under this subtitle, under § 21–202.1 [or], § 21–809, **OR § 21–810** of this article, or under § 10–112 of the Criminal Law Article has failed to appear for trial; or

(3) It is notified by a U.S. District Court that a person cited for a violation under a federal parking regulation:

(i) Has failed to pay the fine for the violation by the date specified in the federal citation; or

(ii) Either has failed to file a notice of [his] **THE PERSON’S** intention to stand trial for the violation, or, if electing to stand trial, has failed to appear for trial.

26–401.

If a person is taken before a District Court commissioner or is given a traffic citation or a civil citation under § 21–202.1 [or], § 21–809, **OR § 21–810** of this article containing a notice to appear in court, the commissioner or court shall be one that sits within the county in which the offense allegedly was committed.

1 SECTION 3. AND BE IT FURTHER ENACTED, That, during the 30-day
2 period after the first work zone speed control system is in place, a law enforcement
3 agency may issue warnings, but may not issue citations, for violations enforced in
4 accordance with § 21–810 of the Transportation Article, as enacted by this Act.

5 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall be
6 construed to apply only prospectively and may not be applied or interpreted to have
7 any effect on or application to any contract awarded before the effective date of this

17 SECTION 7. AND BE IT FURTHER ENACTED, That § 21–809(b)(1)(i), (iii),
18 and (v) of the Transportation Article, as enacted by Section 1 of this Act, does not
19 apply to speed monitoring systems installed and operated in Montgomery County
20 before October 1, 2009.

21 SECTION 8. AND BE IT FURTHER ENACTED, That this Act shall take effect
22 October 1, 2009.
