## A BILL ENTITLED

1 AN ACT concerning

2 **Maryland Consolidated Capital Bond Loan of 2005 – Montgomery County –**  
3 **Old Blair High School Auditorium**

4 FOR the purpose of amending the Maryland Consolidated Capital Bond Loan of 2005  
5 to extend the date by which the Board of Directors of the Old Blair Auditorium  
6 Project, Inc. must present evidence that a matching fund will be provided.

7 BY repealing and reenacting, with amendments,  
8 Chapter 445 of the Acts of the General Assembly of 2005, as amended by  
9 Chapter 65 of the Acts of the General Assembly of 2007 and Chapter 219  
10 of the Acts of the General Assembly of 2008  
11 Section 1(3) Item ZA01(AR) and ZA02(AV)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
13 MARYLAND, That the Laws of Maryland read as follows:

14 **Chapter 445 of the Acts of 2005, as amended by Chapter 65 of the Acts of 2007**  
15 **and Chapter 219 of the Acts of 2008**

16 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
17 MARYLAND, That:

18 (3) ZA01 LOCAL HOUSE OF DELEGATES INITIATIVES

19 (AR) Old Blair High School Auditorium. Provide a grant equal to  
20 the lesser of (i) \$300,000 or (ii) the amount of the matching  
21 fund provided, to the Board of Directors of the Old Blair  
22 Auditorium Project, Inc. for the repair, renovation,  
23 construction, reconstruction, and capital equipping of the Old  
24 Blair High School Auditorium located in Silver Spring.  
25 Notwithstanding Section 1(5) of this Act, the matching fund
