3 FOR the purpose of establishing the State Commission of Real Estate Appraisers and 4 Home Inspectors Fund as a special, nonlapsing fund in the Department of Labor, Licensing, and Regulation; repealing a provision of law requiring the 5 6 State Commission of Real Estate Appraisers and Home Inspectors to pay 7 certain money into the General Fund of the State; authorizing the Commission 8 to set certain fees for its services beginning on a certain date; requiring the 9 Commission to publish a certain fee schedule; requiring the Commission to pay certain fees to the Comptroller beginning on a certain date; requiring the 10 11 Comptroller to distribute certain fees to the Fund; altering certain application, renewal, reinstatement, and license fees; providing for the purpose, 12 administration, composition, use, investments, and expenditures of the Fund; 13 14 requiring the Legislative Auditor to audit the Fund; requiring the Secretary of Labor, Licensing, and Regulation, in consultation with the Commission, to 15 16 calculate certain costs annually; requiring the Commission to establish fees 17 based on certain calculations beginning on a certain date; prohibiting certain 18 fees from increasing more than a certain amount each year; defining certain 19 terms; requiring that certain fees in effect on a certain date shall remain in full 20 force and effect until certain other fees are adopted and made effective; 21 providing for a delayed effective date; and generally relating to the State 22 Commission of Real Estate Appraisers and Home Inspectors Fund.
