## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Voter's Rights Protection Act of 2009**

3 FOR the purpose of altering the circumstances under which an individual may be  
4 offered the opportunity to cast a provisional ballot; requiring the State Board of  
5 Elections to ensure that the program of instruction for election judges  
6 incorporates a thorough and detailed treatment of certain information;  
7 requiring a local board to extend the hours that a polling place shall be open  
8 under certain circumstances; prohibiting a vacancy in polling place staff from  
9 delaying the opening of the polling place; prohibiting an election judge from  
10 requiring a voter to present photo identification before voting, except as  
11 authorized by State or federal law; requiring certain election judges to  
12 document for further investigation any malfunction of the voting system and  
13 other issues that arise during the course of an election; regulating the activities  
14 of challengers or watchers at the polling place; prohibiting certain persons from  
15 distributing, disseminating, or publishing, or being responsible for certain  
16 activities, with respect to any item of campaign material that contains certain  
17 fraudulent representations or implications; ~~prohibiting the use of electronic~~  
18 ~~mail or telephone facilities or equipment with the intent to prevent, obstruct, or~~  
19 ~~delay the broadcast or exchange of certain registration information or the~~  
20 ~~registration of a person having a lawful right to register; prohibiting the use of~~  
21 ~~electronic mail or telephone facilities or equipment with the intent to prevent,~~  
22 ~~obstruct, or delay the broadcast or exchange of election related information, or~~  
23 ~~the use of a telecommunications device to engage in certain communication;~~  
24 ~~making conforming changes; defining certain terms; prohibiting certain election~~

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF  
 24 MARYLAND, That the Laws of Maryland read as follows:

25 **Article – Election Law**

26 9-404.

27 (a) If an individual is eligible under subsection (b) of this section, the  
 28 individual shall be issued and may cast a provisional ballot:

29 (1) at a polling place on election day; or

30 (2) at the local board office in the county where the individual resides  
 31 after the close of registration and before the closing of the polls on election day.

32 (b) An individual is eligible to cast a provisional ballot if:

33 (1) the individual declares in a written affirmation submitted with the  
 34 provisional ballot that the individual is a registered voter in the State and is eligible to  
 35 vote in that election; and

36 (2) (i) the individual's name does not appear on the precinct  
 37 register;

1 (ii) an election official asserts that the individual is not eligible  
2 to vote; [or]

3 (iii) the individual does not have the necessary identification; **OR**

4 **(IV) A CHIEF ELECTION JUDGE DETERMINES THAT THERE IS**  
5 **A PROBLEM OUTSIDE OF THE VOTER'S CONTROL THAT CAUSES THE VOTER TO**  
6 **BE UNABLE TO VOTE A REGULAR BALLOT.**

7 (c) **(1)** In addition to the individuals who cast provisional ballots under  
8 subsections (a) and (b) of this section, any individual who appears to vote during a  
9 period covered by a court order or other order extending the time for closing the polls  
10 shall cast a provisional ballot.

11 **(2)** A provisional ballot cast under **PARAGRAPH (1) OF** this subsection  
12 shall be separated and held apart from other provisional ballots cast by those not  
13 affected by the order.

15 (a) In consultation with the local boards, the State Board shall:

16 (1) develop a program of instruction of election judges; [and]

17 **(2) ENSURE THAT THE PROGRAM OF INSTRUCTION**  
18 **INCORPORATES A THOROUGH AND DETAILED TREATMENT OF THE DUTIES AND**  
19 **LIMITATIONS OF ELECTION JUDGES UNDER STATE AND FEDERAL ELECTION**  
20 **LAW; AND**

21 ~~[(2)]~~ **(3)** oversee the implementation of the program of instruction.

22 (b) The training materials utilized by the program may include:

23 (1) an instruction manual and other written directives;

24 (2) curriculum for training sessions; and

25 (3) audiovisuals.

26 (c) The State Board shall develop a process for the evaluation of the training  
27 program and the performance of the polling place staff in each county.

28 (d) **(1)** To the extent appropriate, the training program shall be specific to  
29 each of the voting systems used in polling places in the State.

1           **(2) ELECTION JUDGES SHALL BE TRAINED TO OPERATE**  
2 **EFFECTIVELY THE VOTING SYSTEM AND ALL OF ITS FEATURES, INCLUDING**  
3 **FEATURES DESIGNED TO ENSURE COMPLIANCE WITH THIS SECTION AND STATE**  
4 **AND FEDERAL LAWS RELATED TO VOTERS WITH DISABILITIES.**

5           (e) The State Board shall provide election judges with uniform statewide  
6 training on the voting system, including:

7                   (1) all features of the voting system that provide access to voters with  
8 disabilities; and

9                   (2) the rights of voters with disabilities, including those rights  
10 guaranteed by State and federal law.

11           (f) Each local board shall conduct election judge training based on the  
12 program developed by the State Board.

13           (g) (1) Except as provided in paragraph (2) of this subsection, each  
14 election judge shall participate in the training program provided for in subsection (a)  
15 of this section.

16                   (2) An election judge who is appointed under emergency circumstances  
17 is not required to attend the course of instruction.

19           (a) **[On] SUBJECT TO SUBSECTION (B) OF THIS SECTION, ON** an election  
20 day, a polling place shall be open from 7 a.m. until 8 p.m.

21           **(B) IF FOR ANY REASON A POLLING PLACE IS CLOSED FOR MORE THAN**  
22 **1 HOUR BETWEEN 7 A.M. AND 8 P.M. ON AN ELECTION DAY, THE LOCAL BOARD**  
23 **SHALL:**

24                   (1) **REQUIRE THE ELECTION JUDGES IN THAT POLLING PLACE TO**  
25 **KEEP THE POLLING PLACE OPEN FOR AN ADDITIONAL PERIOD OF TIME EQUAL**  
26 **TO THE PERIOD THAT THE POLLING PLACE WAS CLOSED, BUT NOT TO EXCEED 2**  
27 **HOURS;**

28                   (2) **PROMPTLY NOTIFY THE STATE ADMINISTRATOR; AND**

29                   (3) **CONSISTENT WITH THE INSTRUCTIONS FROM THE STATE**  
30 **ADMINISTRATOR, NOTIFY THE PUBLIC OF THE EXTENDED VOTING HOURS.**

31           **[(b)] (C)** A voter who has appeared at a polling place by the closing hour to  
32 cast a ballot shall be allowed to vote.

2 (A) A VACANCY IN THE POLLING PLACE STAFF MAY NOT DELAY THE  
3 OPENING OF THE POLLING PLACE.

4 [(a)] (B) If there is a vacancy in the polling place staff during voting hours:

5 (1) the local board may fill the vacancy with a substitute election judge  
6 who has been recruited and trained; or

7 (2) an election judge who is present at the polling place may fill the  
8 position of the absent election judge by appointing a person registered with the same  
9 party affiliation as the absent election judge.

10 [(b)] (C) If a substitute election judge is appointed under subsection [(a)]  
11 (B) of this section:

12 (1) either the election director, the election director's designee, or the  
13 election judge making the substitute appointment shall administer the oath required  
14 under § 10-204 of this title; and

15 (2) a chief election judge shall document any change in the polling  
16 place staff in the records of the polling place.

17 10-310.

18 (a) For each individual who seeks to vote, an election judge, in accordance  
19 with instructions provided by the local board, shall:

20 (1) locate the individual's name in the precinct register and locate the  
21 preprinted voting authority card and then authorize the individual to vote a regular  
22 ballot;

23 (2) (i) if the individual's name is not found on the precinct register,  
24 search the inactive list and if the name is found, authorize the individual to vote a  
25 regular ballot; or

26 (ii) if the individual's name is not on the inactive list, refer the  
27 individual for provisional ballot voting under § 9-404 of this article;

28 (3) **SUBJECT TO SUBSECTION (B) OF THIS SECTION,** establish the  
29 identity of the voter by requesting the voter to state the month and day of the voter's  
30 birth and comparing the response to the information listed in the precinct register;

31 (4) (i) except if a voter's personal information has been deemed  
32 confidential by the local board, verify the address of the voter's residence; or

1                   (ii) conduct an alternative verification as established by the  
2 State Board, if the voter's personal information has been deemed confidential by the  
3 local board;

4                   (5) if any changes to the voting authority card are indicated by a voter,  
5 make the appropriate changes in information on the card or other appropriate form;  
6 and

7                   (6) have the voter sign the voting authority card and either issue the  
8 voter a ballot or send the voter to a machine to vote.

9                   **(B) AN ELECTION JUDGE MAY REQUIRE A VOTER TO PRESENT**  
10 **IDENTIFICATION BEFORE ALLOWING THE VOTER TO CAST A BALLOT ONLY TO**  
11 **THE EXTENT AUTHORIZED OR REQUIRED BY STATE OR FEDERAL LAW.**

12                   [(b)] (C) On the completion of the procedures set forth in subsection (a) of  
13 this section, a voter may vote in accordance with the procedures appropriate to the  
14 voting system used in the polling place.

15                   [(c)] (D) (1) Before a voter enters a voting booth, at the request of the  
16 voter, an election judge shall:

17                                   (i) instruct the voter about the operation of the voting system;  
18 and

19                                   (ii) allow the voter an opportunity to operate a model voting  
20 device, if appropriate to the voting system in use.

21                                   (2) (i) 1. After a voter enters the voting booth, at the request of  
22 the voter, two election judges representing different political parties shall instruct the  
23 voter on the operation of the voting device.

24                                                           2. An election judge may not suggest in any way how the  
25 voter should vote for a particular ticket, candidate, or position on a question.

26                                                           3. After instructing the voter, the election judges shall  
27 exit the voting booth and allow the voter to vote privately.

28                                   (ii) A voter may take into the polling place any written or  
29 printed material to assist the voter in marking or preparing the ballot.

30                                   (3) (i) Except as provided in subparagraph (ii) of this paragraph, a  
31 voter who requires assistance in marking or preparing the ballot because of a physical  
32 disability or an inability to read the English language may choose any individual to  
33 assist the voter.

1 (ii) A voter may not choose the voter's employer or agent of that  
2 employer or an officer or agent of the voter's union to assist the voter in marking the  
3 ballot.

4 (4) If the voter requires the assistance of another in voting, but  
5 declines to select an individual to assist, an election judge, in the presence of another  
6 election judge that represents another political party, shall assist the voter in the  
7 manner prescribed by the voter.

8 (5) An individual assisting a voter may not suggest in any way how  
9 the voter should vote for a particular ticket, candidate, or position on a question.

10 (6) If a voter requires assistance under paragraph (4) or (5) of this  
11 subsection, the election judge shall record, on a form prescribed by the State Board,  
12 the name of the voter who required assistance and the name of the individual  
13 providing assistance to the voter.

14 (7) Except as provided in paragraph (3) or (4) of this subsection, an  
15 individual over the age of 12 years may not accompany a voter into a voting booth.

16 **(E) CONSISTENT WITH INSTRUCTIONS PROVIDED IN THE MANUAL FOR**  
17 **ELECTION JUDGES, DURING THE COURSE OF THE ELECTION THE CHIEF**  
18 **ELECTION JUDGES SHALL KEEP A LOG OF ISSUES THAT ARISE IN THE POLLING**  
19 **PLACE, INCLUDING:**

20 **(1) ANY ALLEGED MALFUNCTION OF THE VOTING EQUIPMENT;**

21 **(2) ISSUES THAT MAY REQUIRE FURTHER INVESTIGATION; AND**

22 **(3) ISSUES REGARDING THE CONDUCT OF CHALLENGERS AND**  
23 **WATCHERS.**

25 (a) (1) The following persons or entities have the right to designate a  
26 registered voter as a challenger or a watcher at each place of registration and election:

27 (i) the State Board for any polling place in the State;

28 (ii) a local board for any polling place located in the county of  
29 the local board;

30 (iii) a candidate;

31 (iv) a political party; and

1 (v) any other group of voters supporting or opposing a  
2 candidate, principle, or proposition on the ballot.

3 (2) A person who appoints a challenger or watcher may remove the  
4 challenger or watcher at any time.

5 (b) Except as provided in § 10–303(d)(2) of this subtitle and subsection (d) of  
6 this section, a challenger or watcher has the right to:

7 (1) enter the polling place one-half hour before the polls open;

8 (2) enter or be present at the polling place at any time when the polls  
9 are open;

10 (3) remain in the polling place until the completion of all tasks  
11 associated with the close of the polls under § 10–314 of this subtitle and the election  
12 judges leave the polling place;

13 (4) maintain a list of registered voters who have voted, or individuals  
14 who have cast provisional ballots, and take the list outside of the polling place; and

15 (5) enter and leave a polling place for the purpose of taking outside of  
16 the polling place information that identifies registered voters who have cast ballots or  
17 individuals who have cast provisional ballots.

18 (c) (1) (i) A certificate signed by any party or candidate shall be  
19 sufficient evidence of the right of a challenger or watcher to be present in the voting  
20 room.

21 (ii) The State Board shall prescribe a form that shall be  
22 supplied to the challenger or watcher by the person or entity designating the  
23 challenger or watcher.

24 (2) A challenger or watcher shall be positioned near the election  
25 judges and inside the voting room so that the challenger or watcher may see and hear  
26 each person as the person offers to vote.

27 (d) (1) A challenger or watcher may not attempt to:

28 (i) ascertain how a voter voted or intends to vote;

29 (ii) converse in the polling place with any voter;

30 (iii) assist any voter in voting; [or]

31 (iv) physically handle an original election document **OR ANY**  
32 **VOTING EQUIPMENT;**



1 (V) MAKE A CHALLENGE ~~INDISCRIMINATELY OR~~ WITHOUT  
2 GOOD CAUSE; OR

3 (VI) INTERFERE WITH OR UNDULY DELAY THE WORK OF AN  
4 ELECTION JUDGE; ~~OR~~

7 (2) An election judge may eject a challenger or watcher who violates  
8 the prohibitions under paragraph (1) of this subsection.

9 (e) (1) Except as provided in paragraphs (2) and (3) of this subsection, an  
10 election judge shall permit an individual other than an accredited challenger or  
11 watcher who desires to challenge the right to vote of any other individual to enter the  
12 polling place for that purpose.

13 (2) A majority of the election judges may limit the number of  
14 nonaccredited challengers and watchers allowed in the polling place at any one time  
15 for the purpose of challenging the right of an individual to vote.

16 (3) A nonaccredited challenger or watcher shall leave the polling place  
17 as soon as a majority of the election judges decides the right to vote of the individual  
18 challenged by the challenger or watcher.

19 (4) In addition to restrictions provided under this subsection, all  
20 restrictions on the actions of an accredited challenger or watcher provided under this  
21 subtitle apply to a nonaccredited challenger or watcher.
