State Government – Human Relations – Discrimination by Business Establishments Against Individuals with Disabilities

4 FOR the purpose of guaranteeing individuals with disabilities full and equal access to business establishments; prohibiting a business establishment from denying or 5 6 abridging the right to full and equal access of an individual with a disability; 7 establishing that each individual denial or abridgement of rights constitutes a 8 violation of the requirements of this Act; prohibiting a business establishment from violating the Americans with Disabilities Act; providing a certain 9 exception; providing an administrative remedy for an aggrieved individual; 10 providing a private right of action for an aggrieved individual; providing for 11 12 certain damages and other relief that may be awarded to an aggrieved individual; authorizing a court to award certain costs and reasonable fees to the 13 prevailing party; providing for the construction of this Act; defining certain 14 terms; and generally relating to disability discrimination by business 15 establishments. 16
