A BILL ENTITLED

1 AN ACT concerning

2 Domestic Violence - Interim and Temporary Protective Orders - Custody of 3 Minor Child

- FOR the purpose of authorizing a judge to order a law enforcement officer to use all
 reasonable and necessary force to enforce a temporary custody provision of an
 interim or temporary protective order; and generally relating to domestic
 violence protective orders.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF 14 MARYLAND, That the Laws of Maryland read as follows:

- 16 4–504.1.

(a) A petition under this subtitle may be filed with a commissioner when
neither the office of the clerk of the circuit court nor the Office of the District Court
Clerk is open for business.

20 (b) If a petition is filed with a commissioner and the commissioner finds that 21 there are reasonable grounds to believe that the respondent has abused a person 22 eligible for relief, the commissioner may issue an interim protective order to protect a 23 person eligible for relief.

24 (c) An interim protective order may:



1 order the respondent to refrain from further abuse or threats of (1) $\mathbf{2}$ abuse of a person eligible for relief; 3 (2)order the respondent to refrain from contacting, attempting to contact, or harassing a person eligible for relief; 4 $\mathbf{5}$ order the respondent to refrain from entering the residence of a (3)6 person eligible for relief: 7 (4)if a person eligible for relief and the respondent are residing together at the time of the alleged abuse: 8 9 (i) order the respondent to vacate the home immediately: 10 (ii) award to a person eligible for relief custody of any child of 11 the person eligible for relief and respondent then residing in the home; and 12(iii) subject to the limits as to a nonspouse specified in § 13 4-505(a)(2)(iv) of this subtitle, award temporary use and possession of the home to the 14 person eligible for relief; 15in a case alleging abuse of a child, award temporary custody of a (5)16 minor child of the respondent and a person eligible for relief; 17 $(\mathbf{6})$ in a case alleging abuse of a vulnerable adult, subject to the limits as to a nonspouse specified in § 4-505(a)(2)(iv) of this subtitle, award temporary use 18 19 and possession of the home to an adult living in the home; 20order the respondent to remain away from the place of (7)21employment, school, or temporary residence of a person eligible for relief; or 22order the respondent to remain away from the residence of any (8)family member of a person eligible for relief. 2324IF THE JUDGE AWARDS TEMPORARY CUSTODY OF A MINOR CHILD **(D)** 25UNDER SUBSECTION (C)(4)(II) OF THIS SECTION, THE JUDGE MAY ORDER A LAW 26ENFORCEMENT OFFICER TO USE ALL REASONABLE AND NECESSARY FORCE TO 27RETURN THE MINOR CHILD TO THE CUSTODIAL PARENT AT THE TIME OF 28SERVICE OR AS SOON AS POSSIBLE AFTER ENTRY OF THE INTERIM PROTECTIVE 29 **ORDER.**

[(d)] (E) (1) (i) An interim protective order shall state the date, time,
 and location for the temporary protective order hearing and a tentative date, time, and
 location for a final protective order hearing.

A temporary protective order hearing shall be held on the 1 (ii) $\mathbf{2}$ first or second day on which a District Court judge is sitting after issuance of the 3 interim protective order, unless the judge continues the hearing for good cause. 4 (2)An interim protective order shall include in at least 10-point bold $\mathbf{5}$ type: 6 (i) notice to the respondent that: 7 1. the respondent must give the court written notice of 8 each change of address; 9 2. if the respondent fails to appear at the temporary protective order hearing or any later hearing, the respondent may be served with any 10 11 orders or notices in the case by first-class mail at the respondent's last known 12address; the date, time, and location of the final protective 13 3. order hearing is tentative only, and subject to change; and 14154. if the respondent does not attend the temporary 16 protective order hearing, the respondent may call the Office of the Clerk of the District 17Court at the number provided in the order to find out the actual date, time, and 18 location of any final protective order hearing; 19 a statement of all possible forms and duration of relief that a (ii) temporary protective order or final protective order may contain; 20notice to the petitioner and respondent that, at the hearing, 21(iii) 22a judge may issue a temporary protective order that grants any or all of the relief 23requested in the petition or may deny the petition, whether or not the respondent is in 24court; 25(iv) a warning to the respondent that violation of an interim protective order is a crime and that a law enforcement officer shall arrest the 2627respondent, with or without a warrant, and take the respondent into custody if the 28officer has probable cause to believe that the respondent has violated any provision of 29 the interim protective order: and 30 the phone number of the Office of the District Court Clerk. (**v**) 31[(e)] **(F)** Whenever a commissioner issues an interim protective order, the 32commissioner shall: 33 (1)immediately forward a copy of the petition and interim protective order to the appropriate law enforcement agency for service on the respondent; and 34

4	[(f)] (G) A law enforcement officer shall:
5 6	(1) immediately on receipt of a petition and interim protective order, serve them on the respondent named in the order; and
7 8 9	(2) immediately after service, make a return of service to the commissioner's office or, if the Office of the District Court Clerk is open for business, to the Clerk.
10	[(g)] (H) An interim protective order shall be effective until the earlier of:

$\begin{array}{c} 13\\14 \end{array}$	(2) the end of the second business day the Office of the Clerk of the District Court is open following the issuance of an interim protective order.
15 16 17 18	[(h)] (I) A decision of a commissioner to grant or deny relief under this section is not binding on, and does not affect any power granted to or duty imposed on, a judge of a circuit court or the District Court under any law, including any power to grant or deny a petition for a temporary protective order or final protective order.

20 21 22 23	(a) (1) If, after a hearing on a petition, whether ex parte or otherwise, a judge finds that there are reasonable grounds to believe that a person eligible for relief has been abused, the judge may enter a temporary protective order to protect any person eligible for relief from abuse.
$\begin{array}{c} 24 \\ 25 \end{array}$	(2) The temporary protective order may order any or all of the following relief:
$\begin{array}{c} 26 \\ 27 \end{array}$	$(i) \qquad \mbox{order the respondent to refrain from further abuse or threats} of abuse of a person eligible for relief;}$
28 29	(ii) order the respondent to refrain from contacting, attempting to contact, or harassing any person eligible for relief;

home immediately and award temporary use and possession of the home to the person 1 $\mathbf{2}$ eligible for relief or in the case of alleged abuse of a child or alleged abuse of a 3 vulnerable adult, award temporary use and possession of the home to an adult living 4 in the home, provided that the court may not grant an order to vacate and award temporary use and possession of the home to a nonspouse person eligible for relief $\mathbf{5}$ unless the name of the person eligible for relief appears on the lease or deed to the 6 home or the person eligible for relief has resided in the home with the respondent for a $\mathbf{7}$ period of at least 90 days within 1 year before the filing of the petition; 8

9 (v) order the respondent to remain away from the place of 10 employment, school, or temporary residence of a person eligible for relief or home of 11 other family members;

12 (vi) order the respondent to remain away from a child care 13 provider of a person eligible for relief while a child of the person is in the care of the 14 child care provider; and

(vii) award temporary custody of a minor child of the personeligible for relief and the respondent.

17 (3) IF THE JUDGE AWARDS TEMPORARY CUSTODY OF A MINOR 18 CHILD UNDER PARAGRAPH (2)(VII) OF THIS SUBSECTION, THE JUDGE MAY 19 ORDER A LAW ENFORCEMENT OFFICER TO USE ALL REASONABLE AND 20 NECESSARY FORCE TO RETURN THE MINOR CHILD TO THE CUSTODIAL PARENT 21 AT THE TIME OF SERVICE OR AS SOON AS POSSIBLE AFTER ENTRY OF THE 22 TEMPORARY PROTECTIVE ORDER.
