11 12	SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That the Laws of Maryland read as follows:

15 16 17	(i) (1) Subject to paragraphs (2) and (3) of this subsection, "socially and economically disadvantaged individual" means a citizen or lawfully admitted permanent resident of the United States who is:

in any of the following minority groups: (i)

- 19 1. African American – an individual having origins in any of the black racial groups of Africa; 20
- 21 American Indian/Native American - an individual having origins in any of the original peoples of North America and who is a 22

- 1 documented member of a North American tribe, band, or otherwise has a special
- 2 relationship with the United States or a state through treaty, agreement, or some
- 3 other form of recognition. This includes an individual who claims to be an American
- 4 Indian/Native American and who is regarded as such by the American Indian/Native
- 5 American community of which the individual claims to be a part, but does not include
- 6 an individual of Eskimo or Aleutian origin;
- 7 3. Asian an individual having origins in the Far East,
- 8 Southeast Asia, or the Indian subcontinent, and who is regarded as such by the
- 9 community of which the person claims to be a part;
- 10 4. Hispanic an individual of Mexican, Puerto Rican,
- 11 Cuban, Central or South American, or other Spanish culture or origin, regardless of
- 12 race, and who is regarded as such by the community of which the person claims to be a
- 13 part;
- 5. physically or mentally disabled an individual who
- 15 has an impairment that substantially limits one or more major life activity, who is
- 16 regarded generally by the community as having such a disability, and whose disability
- 17 has substantially limited his or her ability to engage in competitive business; or
- 18 6. women a woman, regardless of race or ethnicity,
- 19 unless she is also a member of an ethnic or racial minority group and elects that
- 20 category in lieu of the gender category; or
- 21 (ii) otherwise found by the certification agency to be a socially
- 22 and economically disadvantaged individual.
- 23 (2) There is a rebuttable presumption that an individual who is a
- 24 member of a minority group under paragraph (1)(i) of this subsection is socially and
- 25 economically disadvantaged.
- 26 (3) An individual whose personal net worth exceeds [\$1,500,000]
- \$3,000,000 may not be found to be economically disadvantaged.
- SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
- 29 October 1, 2009.
