3 FOR the purpose of requiring the State Board of Social Work Examiners to notify
4 applicants for licensure whether the applicants have been approved to take a
5 certain examination within a certain time period; ~~altering certain requirements~~
6 ~~for a waiver of examination requirements for certain applicants who are~~
7 ~~licensed or registered to practice social work in other states~~ requiring the Board
8 of Social Work Examiners to establish a workgroup consisting of a certain
9 membership to examine certain issues affecting the status of the workforce and
10 submit a report to certain committees of the General Assembly on or before a
11 certain date; and generally relating to the licensure of social workers.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF
18 MARYLAND, That the Laws of Maryland read as follows:

19 **Article - Health Occupations**

20 19-303.

1 (a) To apply for a license, an applicant shall:

2 (1) Submit an application to the Board on the form that the Board
3 requires; and

4 (2) Pay to the Board the application fee set by the Board.

5 (b) The Board shall:

6 (1) Review each application; and

7 (2) Notify each applicant whether the applicant has been approved to
8 take the pertinent licensure examination within [a reasonable time frame as defined
9 in regulations] ~~30 DAYS AFTER THE DATE THE APPLICANT SUBMITTED AN~~
10 ~~APPLICATION TO THE BOARD~~ **60 DAYS FROM THE DATE THE BOARD RECEIVED A**
11 **COMPLETED APPLICATION FROM THE APPLICANT.**

13 ~~(a) Subject to the provisions of this section, the Board shall waive the~~
14 ~~examination requirements of this title for an applicant who is licensed or registered to~~

17 ~~THIS SECTION, THE Board may grant a waiver under this section only if the~~

27 ~~STANDING in another state [under requirements substantially equivalent to the~~

30 ~~(iv) Became licensed or registered in the other state after~~
31 ~~passing in that or any other state an examination [that is the same as the~~

2 ~~REGISTERED AS A SOCIAL WORKER; and~~

3 ~~(4) Did not previously receive a waiver of the examination~~
4 ~~requirement from the Board.~~

5 ~~(C) SUBSECTION (B)(3)(IV) OF THIS SECTION DOES NOT APPLY TO AN~~
6 ~~APPLICANT WHO WAS LICENSED OR REGISTERED IN ANOTHER STATE BEFORE~~
7 ~~JANUARY 1, 1991.~~

8 SECTION 2. AND BE IT FURTHER ENACTED, That the Board of Social Work
9 Examiners shall establish a workgroup consisting of Board members, representatives
10 of social worker associations, human service providers who employ social workers, and
11 other interested stakeholders, to:

12 (1) examine and make recommendations on the licensure statute and
13 the process by which licenses are issued;

14 (2) examine issues affecting the status of the workforce in the State,
15 including examination requirements, reciprocity with other states, supervision
16 requirements, and other relevant issues; and

17 (3) on or before January 1, 2010, report its findings and
18 recommendations, in accordance with § 2-1246 of the State Government Article, to the
19 Senate Education, Health, and Environmental Affairs Committee and the House
20 Health and Government Operations Committee.

21 SECTION ~~2~~ 3. AND BE IT FURTHER ENACTED, That this Act shall take
22 effect October 1, 2009.
