CHAPTER _____

1 AN ACT concerning

Maryland Trauma Physician Services Fund – Rural Trauma Centers <u>–</u> <u>Reimbursement</u>

FOR the purpose of altering the definition of trauma center to include Peninsula 4 Regional Medical Center, the Western Marvland Health System, and $\mathbf{5}$ 6 Washington County Hospital altering the maximum number of trauma on-call 7 hours per year that a Level III trauma center is eligible for reimbursement for 8 from the Maryland Trauma Physician Services Fund; providing that the cost 9 incurred by a Level III trauma center to maintain trauma physicians on call shall include certain practice areas under certain circumstances; requiring the 10 Maryland Health Care Commission to make a certain determination on or 11 before a certain date each year; prohibiting the Commission from making 12 certain reimbursements under certain circumstances; providing for the 13 termination of this Act; and generally relating to the Maryland Trauma 14 Physician Services Fund. 15
