2 3 4	(i) meets or exceeds the current version of the U.S. Green Building Council's LEED (Leadership in Energy and Environmental Design) Green Building Rating System Silver rating; or			
5 6 7 8	(ii) achieves at least a comparable numeric rating according to a nationally recognized, accepted, and appropriate numeric sustainable development rating system, guideline, or standard approved by the Secretaries of Budget and Management and General Services.			
9	(3) "Major renovation" means the renovation of a building where:			
10	(i) the building shell is to be reused for the new construction;			
11 12	(ii) the heating, ventilating, and air conditioning (HVAC), electrical, and plumbing systems are to be replaced; and			
13	(iii) the scope of the renovation is 7,500 square feet or greater.
